2. List of points discussed and conclusions

2.1 New mandates

2.2 Draft Opinions (for discussion):

- Hair dye Tetrabromophenol Blue, 4,4'-(4,5,6,7-tetrabromo-1,1-dioxido-3H-2,1-benzoxathiol-3-yliden)bis-2,6-dibromophenol (CAS 4430-25-5)- Colipa No. C183 – Submission IV. The preliminary version of the Opinion is foreseen for finalisation at the next August meeting.
- Hair dye Methylimidazoliumpropyl p-phenylenediamine HCl (A166) (CAS 220158-86-1). Submission I - the draft Opinion has been discussed and finalised. It is planned to adopt the preliminary Opinion via written procedure after the meeting.

- Hair dye Indigofera tinctoria (C170) (CAS 84775-63-3). Submission III – The SCCS prepared a last request to the Applicant. The dossier is on hold until October 2019.
- Aluminium – The draft Opinion has been discussed and new tasks have been distributed among members. It will be further discussed at the next August meeting.
- Zinc pyrithione (P81) (CAS No 13463-41-7, EC No 236-671-3) – the dossier has been discussed among members and a first draft will be discussed at the next August meeting.
- Submission I on the use of Dihydroxyacetone (DHA) as hair colorant. A first draft will be discussed at the next August meeting.

2.3 Comments on Opinions

- Allergy Alert Test (AAT) as a proof-of-concept study to elicit a signal recognizable by laypersons – comments received have been forwarded to the SCCS for consideration. They will be further discussed at the next August meeting.
- Hair dye Hydroxypropyl p-phenylenediamine and its dihydrochloride salt (A165). Submission I is still under **commenting period until 9/9/2019**.
- Methoxypropylamino Cyclohexenylidene Ethoxyethylcyanoacetate (S87) - Submission II – the dossier is on hold until November 2019 upon request from the Applicant and agreement from DG GROW.

3. Information from chairman/members/commission

- SCCS members, *Janine Ezendam and Vera Rogiers*, reported from their participation in the Cosmetics Europe (CoE) skin sensitisation workshop on 26-27 June to present the SCCS view. SCCS drafted a note to be sent by the Secretariat to CoE for the follow-up.
