Scope of the meeting between AFSSET and SCHER WG was to avoid as much as possible any potential divergent opinions between the two committees.

The meeting focused exclusively on discussing scientific data and risk assessment related to that specific topic.

It was clarified that the mandate to SCHER was strictly related to the Danish EPA report and did not involve any discussion linked to the REACh Regulation.
