Mission on Cancer – Implementation

Guiding Principles



- **To go beyond research and innovation:** cancer is a societal challenge that requires coordinated efforts for effective action, not achievable via traditional research methods only (e.g. complementarity between the Mission and the Europe's Beating Cancer Plan);
- **'Holistic' policy approach:** an enabling environment is crucial to achieve the mission's goals, requiring targeted policies and revised/adapted regulatory frameworks (e.g. Chemicals Strategy for Sustainability, Pharma Strategy, Green Deal, review of Occupational Health and Safety Framework).
- **Co-implementation:** citizens - including patients, survivors and carers, stakeholders, are active mission co-implementers, alongside with Member States, the Mission Board, the Commission and the European Parliament.
- **Financing:** multiple channels via Horizon Europe, other MFF instruments, EIB, and other funding streams.

Mission on Cancer – Implementation

UNDER PREPARATION



Preparatory phase (next 6 to 12 months):

- **Prepare implementation plan:** definition of intervention logic, actions to be supported, indicators, investment strategy (“Roadmap for Implementation 2021-2027”).
- **Feasibility check in 2021:** all missions will be subject to a final assessment against the criteria defined for missions as described in Horizon Europe draft legal text (art 7(3) of the FP/RfP Regulation).
- **Budget:** 5 million EUR for each mission through separate HE work programme 2021 to support actions for rapid scaling up of investments, after concluding the preparatory phase.

Transnational cooperation and national deployment of the missions: creation of a **Missions Core Network** will prepare the ground for implementation in each Member State, and foster cooperation between Member States, consisting of to-be-established **Missions National Hubs**.
