MINUTES

1. Welcome and apologies, approval of the agenda and declaration of interests

The Chair welcomed all the participants. There were three apologies.

The agenda was adopted.

2. List of points discussed and conclusions

2.1 New mandates

There is no new mandate.

DG GROW informed that a mandate for the risk assessment of Zinc Pyrithione (after its classification as CMR 1B) will be submitted around Easter.

DG GROW was informed that cannabidiol and hemp (oil) are of interest to the SCCS for safety evaluation.

DG GROW consulted the SCCS on prioritising a draft list of substances with potential endocrine disrupting properties used in cosmetics, for future safety evaluation.

2.2 Draft Opinions (for discussion):

- Allergy Alert Test (AAT) as a proof-of-concept study to elicit a signal recognizable by laypersons. A first draft of the Opinion was discussed. Comments will be further collected for drafting a revised version for discussion at the next meeting (25 April).
- **UV-filter** Methoxypropylamino Cyclohexenylidene Ethoxyethylcyanoacetate (**S87**) (CAS 1419401-88-9) – Submission II. The draft preliminary Opinion is published and **opened for comments until 13 May**:

- Preservative Hydroxyethoxyphenyl Butanone (HEPB) - P98 - Submission II on eye irritation . The final version was adopted (SCCS/1604/18) and **published**:

DG GROW requested some clarifications on impurities and on acute toxicity (oral and inhalation), which will not change the final published conclusions of the Opinion.
- Fragrance Acetylated Vetiver oil - Submission III. The final version was adopted (SCCS/1599/18) and **published**:

The Applicant requested some clarifications on inhalation exposure, which will not change the final published conclusions of the Opinion.
- Hair dye Tetrabromophenol Blue, 4,4'-(4,5,6,7-tetrabromo-1,1-dioxido-3H-2,1-benzoxathiol-3-ylidene)bis-2,6-dibromophenol (CAS 4430-25-5)- Colipa No. C183 – Submission IV. A request to Applicant was sent following the plenary meeting. The dossier is on hold until April 2019.
- Hair dye Hydroxypropyl p-phenylenediamine and its dihydrochloride salt (A165). Submission I - A request to Applicant was sent prior to the plenary meeting. The dossier is on hold until April 2019.
- Hair dye Methylimidazoliumpropyl p-phenylenediamine HCl (A166) (CAS 220158-86-1). Submission I - A request to Applicant was sent prior to the plenary meeting. The dossier is on hold until April 2019.
- Hair dye Indigofera tinctoria (C170) (CAS 84775-63-3). Submission III - A request to Applicant was sent prior to the plenary meeting. The dossier is on hold until April 2019.
- Aluminium – A request to Applicant was sent prior to the plenary meeting. The dossier is on hold until May 2019.

- Fragrance Butylphenyl methylpropional (p-BMHCA) - SCCS/1591/17 - Submission II: A request to Applicant was sent following the plenary meeting. The Applicant replied the day of the meeting. The SCCS Opinion is planned to be further discussed and finalised at the next meeting (25/04).
- Hair dye 1,2,4-trihydroxybenzene (1,2,4-THB) (A33) (CAS 533-73-3). SCCS/1598/18 - Submission VI – A request to Applicant was sent prior to the plenary meeting. The dossier is on hold until April 2019.
