Scientific Committee on Consumer Safety (SCCS) WG on Nanomaterials in Cosmetic Products

17 July 2019

Minutes

1. Welcome and apologies, approval of the agenda and declaration of interests

The Chair welcomed the participants.

2. List of points to be discussed

2.1. New mandates

- Mandate for an opinion on three coatings for Zinc oxide (nano form) [Methicone (CAS/EC 9004-73-3/ 236-675-5), Silica (CAS/EC 7631-869/231-545-4) and Isostearic acid (CAS/EC 30399-84-9/250178-0)] as UV-filter in dermally applied cosmetic products. The group agreed with the mandate that will be adopted by written procedure after the meeting. A Rapporteur was selected and appointed.

- Draft Opinion on Copper (nano) and Colloidal Copper (nano) CAS No 7440-50-8, EC No. 231-159-6. The content of the dossier was discussed as well as the results from the literature search. Tasks have been distributed among members. The draft will be discussed at the next August WG meeting.
- Draft Opinion on Hydroxyapatite (nano) – submission II . The text was discussed and amendments were made. A clarification regarding the exact reference of a report will need to be requested to the Applicant after the meeting.
- Two coatings for Titanium Dioxide (nano form) (Methicone CAS/EC 9004-73-3/236-675-5 and Perfluorooctyl Triethoxy silane CAS/EC 51851-37-7/257-473-3) as UV-filter in dermally applied cosmetic products : the dossier has been withdrawn by the Applicant.
- Update of the SCCS nano guidance - discussion on contributions and distribution of new tasks.

2.4. Comments on Opinions

- Preliminary Opinion on the Solubility of Synthetic Amorphous Silica (SAS): SCCS responses to comments received were adopted at the plenary meeting and sent back to the respective recipients. The final Opinion was also adopted at plenary meeting and has been published.
