Because of an apparent increase in cosmetic products produced as sprays (e.g. sun products), the SCCS decided to include a section on the safety assessment of such products in the Notes of Guidance.

COLIPA was invited to presented the results of a study its study on consumer exposure to deodorants/antiperspirants in aerosol form.

The outcome of the ECVAM/EPPIA workshop on the 3T3 NRU Phototoxicity test, and in particular the practical experience and implications for phototoxicity testing were discussed.
