UNCAN.eu platform

Objective:

To collect, share and analyse research and patient health data + other relevant data to gain new and deeper understanding of cancer mechanisms, focusing on poorly-understood cancers

Main expected features:

- Federated platform of national cancer data hubs utilising existing, relevant research infrastructures
- Development of new models and digital technologies
- Integration with other data platforms, such as a Network of comprehensive cancer infrastructures and the European Cancer Patient Digital Centre

- 4.UNCAN.eu CSA started Sept 22; duration 15 months
- Aim: to develop the blueprint and operational concept of the platform
- Beneficiary: consortium formed by 29 legal entities from 21 EU countries including cancer centres, hospitals, research institutes, few companies, and cancer patient organisations





European Cancer Patient Digital Centre

Objective

Information and support for cancer patients, survivors and their families

Main expected features:

- EU virtual network of national infrastructures of patient-controlled health data
- All national nodes have common features + country-specific functions + connection to cancer registries
- Provide to patients a secure environment to access and share electronic health data for prevention and treatments across borders
- Tools for patient-reported data collection and for participating to research (e.g. trials)

- ECPDC Study tender started Dec 2022, duration 8 months
- Aim: establish blueprint of ECPDC
- Beneficiary: Berlin Institute of Health @Charite





Network of national Cancer Mission Hubs

Overall objective

To support implementation of Cancer Mission activities by establishing Mission Hubs operating at national, regional and local levels in MS and Associated Countries

Main activities:

- Awareness raising and coordination of Mission activities among relevant actors in national, regional or local R&I and health systems;
- Facilitate integration of Mission activities at national, regional, and local levels;
- Facilitate engagement of actors and stakeholders beyond R&I and health systems to cover all areas relevant for cancer control, e.g. cross-policy dialogues;
- Support citizen engagement activities.

- ECHoS Establishing of cancer mission hubs: networks and synergies: CSA due to start May 2023; duration 36 months
- Beneficiaries: AICIB Portugal, consortium formed by 56 legal entities from 25 EU countries and 4 AS countries including cancer centres, public agencies, hospitals, research institutes, ministries, and cancer patient organisations





Comprehensive Cancer Infrastructures (CCIs)

Overall objective

To improve or develop existing or future Comprehensive Cancer Infrastructures (CCIs)

Main activities:

- Map maturity of CCIs across all EU Member States (MS)
- Organise a capacity building programme with at least one training session taking place in each MS and Associated Country (AC) in the EU network of Comprehensive Cancer Centres being set up under the Europe's Beating Cancer Plan
- Capacity building programme start in countries without CCIs
- Better integration between research and care

- CCI4EU Comprehensive cancer infrastructures in Europe: CSA due to start June 2023; duration 36 months
- Beneficiary: Organisation of European Cancer Institutes* (OECI) Belgium; Consortium formed by 55 legal
 entities from all 27 MS and 5 AC including the largest Comprehensive Cancer Centres in the EU, many
 affiliates of OECI, public agencies, hospitals, health authorities, ministries, research institutes, and cancer
 patient organisations.

Collaboration in Mission clusters (1)

- Projects are brought together in clusters
- Clusters are developed to build a portfolio of projects that address the goal of the Mission on Cancer.
- The clusters are linked to the Mission's objectives: (1)
 Understanding, (2) Prevention, incl. screening, (3) Diagnosis and treatment, and (4) Quality of life





Collaboration in Mission clusters (2)

- Clusters rationale and aims
 - Support Mission objectives
 - Create added value
 - Increase impact of EU funding
 - Establish policy feedback loop
 - Identify what to work on together

- Clusters EU-funded consortia and EC agree on areas of added value, such as:
 - Data Management
 - Research & Innovation
 - Communication & Dissemination
 - Citizen Engagement
 - Addressing inequalities
 - Research Capacity Building
 - Cancer Mission Hubs





Collaboration in Mission clusters (3)

- Three Project Clusters have been established:
 - Prevention and early detection *started 2022* (6 projects, 6 projects)
 - Understanding *started 2022* (5 projects + CSA 4.UNCAN.eu)
 - Diagnosis and Treatment *started 2023* (12 projects)
 - Quality of Life *starting in 2023*

Footnote in Cancer Mission WP2023: In order to address the objectives of the Mission on Cancer, participants will collaborate in project clusters to leverage EU-funding, increase networking across sectors and disciplines, and establish a portfolio of Cancer Mission R&I and policy actions.
