EU4Health – the programme

EU4Health is a clear message that public health is a priority for Europe and it is the instrument to pave the way to a European Health Union

- RESPONSE TO COVID-19 supporting the fight against cross-border health threats
 and boosting the preparedness and capability to respond effectively to future health
 crises
- **AMBITIOUS VISION** will go beyond crisis response to support and complement national health policies for strengthening and modernizing health systems, reducing inequalities and overcome shared challenges
- THE LARGEST EVER EU INVESTMENT IN HEALTH over EUR 5.3 bn (current prices) invested in health during the next 7 years (2021-27), min. 20 % reserved for health promotion and disease prevention actions
- FORMAL ADOPTION: 26 March 2021 Regulation (EU) 2021/522 EU4Health Programme







EU4Health – general objectives

EU4Health will provide the means and the instruments for delivering on the EU Health policy. Four general objectives represent the breath and the ambitions of the programme:



Improve & foster health in the Union



Protect people from serious cross-border health threats



 Improve access to medicinal products, medical devices, crisis-relevant products



Strengthen health systems









EU4Health – general objectives

EU4Health will be implemented along <u>ten specific objectives</u> that identify key areas of intervention



- Disease prevention & health promotion;
- International health initiatives & cooperation.



- Prevention, preparedness & response to cross-border health threats;
- Complementing national stockpiling of essential crisisrelevant products;
- Establishing a reserve of medical, healthcare & support staff.



 Enhancement of availability, accessibility & affordability of medicinal products, medical devices and crisis-relevant products



- Strengthening health data, digital tools & services, digital transformation of healthcare;
- Enhancing access to healthcare:
- Developing and implementing EU health legislation and evidence-based decision making;
- Integrated work among MS health systems.



AMR in EU4Health

EU4Health Work Programme 2021 adopted in June. Several actions linked to AMR have been included.

- CALL FOR PROPOSALS: ACTION GRANTS SUPPORTING TRAINING ACTIVITIES, IMPLEMENTATION, AND BEST PRACTICES (EUR 7M): capacity building, training and implementation of enhanced infection prevention and control practices and antimicrobial stewardship in hospitals and long-term care facilities as well as antimicrobial stewardship in primary care
- SUPPORT TO THE IMPLEMENTATION OF THE 2017 EU ONE HEALTH ACTION PLAN (EUR 1.5M):
 contracts for inventory of existing barriers to the development and implementation of national
 action plans on AMR and a special Eurobarometer on AMR
- AMR PREPARATION OF HERA (EUR 2M): a service contract for needs assessment and technology review reports (to feed into future work to bring AMR medical countermeasures to market); a service contract for a feasibility study on AMR stockpiling

Projects under EU structural funds

- LT (2014–2020, ERDF) Antimicrobial preparation for treatment of P.aeruginosa infection To peform scientific research and develop new antimicrobial preparation for treatment of P.aeruginosa infection. Budget: € 335.282
- LV (2017-2020, ERDF) Development of new antimicrobial agents targeting Gram-positive bacterial sortase The aim of the project is to develop new antibacterial agents that target the enzyme sortase A found in most Gram-positive bacteria. Budget: € 583.689, co-financing 85%
- LV (2017-2020, ERDF) Long term effects of H.pylori eradication on Gastro intestinal tract microbiome and development of screening system for detection of extended-spectrum beta-lactamase coding genes within feces samples. Budget: € 648.648, 85% co-financing

- All ESF+ specific objectives fall under PO 4: "a more social Europe, implementing the European Pillar of Social Rights"
- Investments in health and long-term care may be envisaged both under PO1 and PO4.



Cohesion policy funds and health 2021-2027



- Will support health system and public health policies, e.g.:
 - healthcare facilities, equipment, eHealth
 - improve access to healthcare
 - stronger primary care, integration of care
 - health promotion and disease prevention
 - active and healthy ageing
 - health workforce training
 - more resilient health systems, critical supplies
- Health authorities need to ensure that projects are part of a broader investment strategy and link to reform agenda

Recovery and Resilience Facility (RRF)

- The centrepiece of the Next Generation EU recovery instrument
- To be operational until 2026
- Effective implementation of Next Generation EU can deliver 2% of additional GDP by 2024 and create 2 million jobs.

National Recovery and Resilience Plans (RRPs)


- Member States prepare and submit their Recovery and Resilience Plans
- RRPs provide an overview of reforms and investments in line with the objectives of the RRF and the European Semester's Country-Specific Recommendations (esp. 2019 and 2020)
- Focus on
 - Mitigating the socio-economic impact of the crisis
 - Supporting the green & digital transitions
 - · Smart, sustainable and inclusive growth
 - Social and territorial cohesion
 - Strengthening health, and economic, social and institutional resilience

Each RRP to include

- min 37% of climate related expenditure
- min 20% of expenditure related to digital

- Health and long-term care infrastructure, including clinics, hospitals, primary care, home services and community-based care
- Innovative health solutions, including e-health, health services and new care models
