Minutes

Mr John F. Ryan, Acting Director SANTE C, welcomed the participants. He introduced each speaker:

• Dr Jean-Claude Schmit, Director of Health, Ministry of Health, Luxembourg

He welcomed the newly appointed members on behalf of the Minister and the Ministry of Health and thanked them for their role in putting science and innovation at service of the European citizens and for protecting citzens' health.

• Mr Xavier Prats Monné, Director General Health and Food Safety - European Commission He welcomed the newly appointed members on behalf of the Commission and said that the Commission was very grateful for their commitment and their desire to help the EU.

• Mr Philippe Roux, Head of Unit SANTE C2

He presented the mission and tasks of the Scientific Committees and announced that the database of experts would be reopened from September 2016, providing an invaluable resource to call upon should additional expertise be needed.

She presented the Scientific Committees' past and current activities as well as future challenges. She also presented some statistics regarding the Opinions provided by the former Committees.

He congratulated all members and presented the Scientific Advise Mechanism and discussed its interaction with the Scientific Committees. The SAM and the Scientific Committees will interact whenever it is useful to do so, he said.

His presentation focused on the interaction among EU risk assessment bodies, including synergies and complementarities. There are substances, scientific developments and working methods of common interest with the Scientific Committees, he said.

He talked about the need for more robust risk assessment (weight of evidence, uncertainties). He is the Chair of EU Agencies Network for Scientific Advice (ANSA), a network of EU agencies that focuses on the safety assessment.
