



# Scientific Committee on Consumer Safety (SCCS) Meeting of the Working Group on Cosmetic Ingredients in Cosmetic Products

19-20 April 2022, Luxembourg

## **Minutes**

## 1. Welcome and apologies, approval of the agenda and declaration of interests

The Chair welcomed the participants. The meeting was organised via AUDIO. One apology was received for both days, one for 1 day ½ and three apologies for ½ day. The agenda was adopted without changes.

#### 2.1 New mandates or information from DG GROW

- The Secretariat informed that the DG GROW public consultation on the targeted revision of the Cosmetic Product Regulation is launched. - DG GROW call for data to identify the various salicylic esters used in cosmetic products that are metabolised to Salicylic Acid in the framework of the Cosmetic

- Benzyl salicylate: tasks have been allocated to members. The draft preliminary Opinion was presented and will be further discussed at the next WG meeting.
- Citral: the dossier has been presented and a draft text might be presented in the next WG meeting.
- C186: the dossier has been presented and tasks have been allocated to members

• The preliminary revision of the Vitamin A (SCCS/1639/21): the SCCS responses to comments received will be further discussed in the next WG meeting, together with the final text of the Opinion.

- The preliminary Opinion on 4-Methylbenzylidene camphor (4-MBC): the SCCS responses to comments received have been discussed and finalised. They are planned to be adopted by written procedure, together with the final text of the Opinion.
- The preliminary Opinion on Genistein/Daidzein: the comments received are under consideration for the finalisation of the Opinion, which is on hold due to requested information expected during the summer.
