Future model of HTA cooperation: Development of the White Paper

Background

- Objective 1.2 in the EUnetHTA JA3 Grant Agreement is to support voluntary cooperation between HTA agencies by providing the scientific and technical mechanism of a permanent European cooperation on HTA.
- To meet this objective EUnetHTA WP1 initiated a piece of work to develop the underlying scientific and technical principles for a future model of HTA cooperation.
- Two key stages:
 - Production of a RoadMap that describes the elements of a model that have already been defined within JA3, the elements that could be improved or are missing and identifying next steps.
 - Production of a White Paper, defining the scientific and technical principles for future HTA cooperation, referring to the elements in the RoadMap.



Status of the work

- Completed RoadMap
- Production of the RoadMap involved a 17 member task group with discussion groups in the Executive Board and Project Managers Group and consultation with EUnetHTA partners
- The RoadMap uses a simple thematic framework, to
 - list existing documents and tools,
 - identify missing elements, and
 - · identify and prioritise areas for improvement.
- Final stage of the work is to transform the RoadMap into a White Paper.
- This final stage of the work has been taken into the Executive Board and the original task group has been stood down.



The White Paper

- The White Paper will be based on the Road Map and also incorporates findings from existing or in progress documents produced by EUnetHTA
- Aim to compile the outputs of EUnetHTA JA3 into a document that describes in a single framework the way we worked, what we have achieved, what we have learnt and what we recommend for the future
- Signposting for those taking HTA cooperation forward:
 - The most relevant documents and tools from JA3
 - The areas of alignment and agreement
 - The areas of disagreement and reasons why
 - The areas requiring further work



FMC White paper general structure

Model of HTA cooperation 1. Concept and strategy 2. Transversal cooperation 3. Project specific cooperation


- Transversal cooperation = elements going across HTA activities
- Project specific cooperation = organised around core outputs ED, JA/CA and PLEG
- Explicit signposting of the interrelationship between sections
 - Underlying rules and principles in section 1 should be reflected in cooperation structures in sections 2 and 3
 - Transversal elements (section 2) and project specific elements (section 3) should be mutually supportive

1. Concept and Strategy

- One chapter, covering:
 - 1. Description of the core outputs: ED, JA, CA, PLEG
 - 2. Links between activities and rationale why these activities as a set are important in HTA cooperation
 - 3. Future expansion beyond core outputs to meet further needs
 - 4. General rules/principles underlying HTA cooperation
- Work included in this chapter has been led by the Executive Board





Common structure for each cooperation chapter (sections 2 and 3)

- 1. Key documents EUnetHTA has produced
- 2. Summary of JA3 ways of working
- 3. Lessons learnt
- 4. Recommendations for a future model
- 5. Recommendations for future work



Development of general rules underlying HTA cooperation

Concept and Strategy prioritised further work



Background

- While the RoadMap was being prepared the Executive Board identified that further work was needed to define general rules underlying a future model of HTA cooperation, for example transparency, confidentiality etc
- General rules = Shared rules and principles that should guide the joint outputs created and/or how the network functions
- Provides an explicit reflection point and a guide to elaborating elements
 - when an element of a model is elaborated, the proposal can be checked against the extent to which it meets the shared rules and principles – adjustments made or reasons for different approach made explicit



Areas where general rules are being developed

Independence and Conflicts of interest

Transparency and Confidentiality

Communication

Evidence and Data inclusion in HTA

Involvement (internal, external, interactions between parties)

Relevance (topic identification) – what makes a project of value

Relevance (scope) – what makes a European scope

Use and Usability – how far should joint HTA go?

Quality systems approach

Timeliness

Review [up to date-ness]

Fairness of procedure



Developing the rules – ongoing work

- 1. The principles
 - For each area 1-3 fundamental principles that you would expect to see underpinning a model of HTA cooperation
- 2. Importance of these principles for HTA cooperation
- 3. Key learnings for developing a model of HTA cooperation
 - Any JA3 or personal learnings that should be highlighted in the White Paper
- 4. Recommendations to support implementation of these principles
 - Structures and processes to support implementation of the principle in a model of HTA cooperation



Hypothetical example 1: Elements should thread through the White Paper sections

Concept and strategy articulates the rule/principle underlying HTA cooperation

HTA should be a participatory process

One aspect of implementing this in project specific cooperation is that:

 The procedures for producing all HTA outputs (ED, JA/CA, PLEG) should normally include an explicit patient and clinical expert contribution

The learning from JA3 is that to implement this at a project specific level requires transversal cooperation structures and processes:

- Personnel to support expert identification and engagement
- IT tools to manage stakeholder information
- Corporate governance policies: conflicts of interest and information governance

Importance for including these in a model - without these transversal cooperation elements, project specific cooperation is less successful meaning that HTA cooperation may not address the underlying participatory principle
