## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### WE ARE

The newly created Health Emergency Preparedness and Response Authority (HERA) which is established as a Directorate General of the European Commission. The HERA shall assist the Commission to improve preparedness and response to serious cross-border threats in the area of medical countermeasures, in particular:

• strengthening health security coordination within the Union involving all relevant actors during preparedness and crisis response times and bringing together the EU Member States, industry and relevant stakeholders in a common effort;

• addressing vulnerabilities and strategic dependencies within the Union related to the development, production, procurement, stockpiling and distribution of medical countermeasures;

• contributing to reinforcing the global health emergency response architecture. The HERA shall be responsible for the following tasks which shall be exercised in close cooperation with the Member States:

• assessment of health threats and intelligence gathering relevant to medical countermeasures;

• promoting advanced research and development of medical countermeasures and related technologies;

• addressing market challenges and boosting the Union's open strategic autonomy in medical countermeasures production; • swift procurement and distribution of medical countermeasures;

increasing stockpiling capacity of medical countermeasures;

 strengthening knowledge and skills in preparedness and response related to medical countermeasures.

The HERA is assisted by the Coordination Committee, the HERA Board and the HERA Advisory Forum. The HERA currently has 4 units. HERA.03 "Medical Counter Measures" focuses on the management of medical counter measures.

#### **WE PROPOSE**

We propose a post of legal officer to give support and advice in contract negotiation, contract implementation, and / or procurement and legal support to the team overseeing the EU's work in developing and procuring medical countermeasures which are needed to tackle current and future



health emergencies. The person recruited will also give broader legal advise and support within DG HERA. This is likely to involve frequent contacts with the representatives of Member States as HERA's primary stakeholders. It is also likely to involve a great deal of contact with commercial organisations involved in the development of medical countermeasures including pharmaceutical industry. The job is therefore highly visible and essential to the crisis response.

### WE LOOK FOR

The job requires the ability to analyse legal texts, and strong negotiation and communication skills. The job holder will be expected to handle the legal side of commercial negotiations. In addition, the job holder could be asked to provide more general legal advice within HERA on more horizontal matters such as access to document, legislative proposal, etc. We look for an experience colleague in this area, eager to contribute to the crisis response, resilient and flexible. Specific attention will be given to applications of candidates with experience of working in a commercial legal environment or who have handled contract negotiations. A very good knowledge of English is needed (oral and written).

#### HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

## 1. Selection

## > Am I eligible to apply?

## You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

## Qualifications:

(a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the  $\ensuremath{\text{EU}^1}$
- AND have a satisfactory knowledge (minimum level B2)<sup>2</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.
- > What about the selection steps?

The selecting unit chooses from the EPSO database<sup>3</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

# candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.



## 2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

## > Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG IV.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 years.** Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
