1. Introduction

The European Commission (hereafter 'the Commission') is committed to protect your personal data and to respect your privacy. The Commission collects and further processes personal data pursuant to [Regulation \(EU\) 2018/1725](#) of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data (repealing Regulation (EC) No 45/2001).

This privacy statement explains the reason for the processing of your personal data, the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to processing operation *EU Convalescent Plasma Database* undertaken by *European Commission: Health and Food Safety (SANTE) Unit D2 Medical products: Quality Safety and Innovation* is presented below.

2. Why and how do we process your personal data?

Purpose of the processing operation: the *European Commission: Health and Food Safety (SANTE) Unit D2 Medical products: Quality Safety and Innovation* collects and uses your personal information exclusively to provide access to the EU Convalescent Plasma Database and will not be used for other compatible purposes.

EU Convalescent Plasma Database users' personal data are stored and managed automatically by the European Commission through EU Login/SAAS systems. These systems assure the controlled access to the EU Convalescent Plasma Database.

Your personal data will not be used for an automated decision-making including profiling.

3. On what legal ground(s) do we process your personal data

We process your personal data, because:

(a) processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body;

(b) processing is necessary in order to protect the vital interests of the data subject or of another natural person.

The basis for the processing has been laid down in [Directive 2002/98/EC](#), also referred to as the European Blood Directive. It covers all steps in the transfusion process from donation, collection, testing, processing, and storage to distribution.

4. Which personal data do we collect and further process?

In order to carry out this processing operation the *European Commission: Health and Food Safety (SANTE) Unit D2 Medical products: Quality Safety and Innovation* collects the following categories of personal data:

- Name of the user;
- Contact details (e-mail address);

The provision of personal data is mandatory.

The provision of personal data is mandatory to meet a technical requirement allowing access to the restricted areas of the EU Convalescent Plasma Database. If you do not provide your personal data, access to restricted part of the EU Convalescent Plasma Database will not be allowed thus preventing the performance of tasks to be carried out in the public interest.

5. How long do we keep your personal data?

The *European Commission: Health and Food Safety (SANTE) Unit D2 Medical products: Quality Safety and Innovation* only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing, namely for as long as you hold your capacity as authorised users of the database.

6. How do we protect and safeguard your personal data?

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored on the servers of the European Commission. All processing operations are carried out pursuant to the [Commission Decision \(EU, Euratom\) 2017/46](#) of 10 January 2017 on the security of communication and information systems in the European Commission.

In order to protect your personal data, the Commission has put in place a number of technical and organisational measures in place. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

7. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to the Commission staff responsible for carrying out this processing operation and to authorised staff according to the “need to know” principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

However, an exchange of information is ensured with the European Blood Alliance, coordinating this initiative.

8. What are your rights and how can you exercise them?

You have specific rights as a ‘data subject’ under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have the right to object to the processing of your personal data, which is lawfully carried out pursuant to Article 5(1)(a) on grounds relating to your particular situation.

You can exercise your rights by contacting the Data Controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor. Their contact information is given under Heading 9 below.
