The eHealth Network is a voluntary network, set up under article 14 of Directive 2011/24/EU.  
It provides a platform of Member States' competent authorities dealing with eHealth.

These guidelines complement and further specify the description of value sets as provided by Annex II of the Commission Implementing Decision (EU) 2021/1073 of 28 June 2021 laying down technical specifications and rules for the implementation of the trust framework for the EU Digital COVID Certificate established by Regulation (EU) 2021/953 of the European Parliament and of the Council.

Adopted by the eHealth Network on 8 May 2023.

## 1 Introduction

Value Sets for the EU Digital COVID Certificate are defined for the datasets provided in the [Regulation \(EU\) 2021/953](#) of the European Parliament and of the Council of 14 June 2021 on a framework for the issuance, verification and acceptance of interoperable COVID-19 vaccination, test and recovery certificates (Digital COVID Certificate) to facilitate free movement during the COVID-19 pandemic.

Annex II of the [Commission Implementing Decision \(EU\) 2021/1073](#) of 28 June 2021, amended by [Commission Implementing Decision \(EU\) 2021/2014](#) of 17 November 2021 describes general rules for all value sets and lists some of them in their entirety.

However, for value sets that are changing often, notably related to vaccine and test device coding, the Implementing Decision indicates that they shall be published and regularly updated by the Commission with the support of the eHealth Network and the Health Security Committee. These guidelines provide this publication.

Codes marked as deprecated should be supported by verifier apps until further notice, as they may appear on certificates issued before deprecation.

Unless indicated otherwise, the codes should be used also for the adapted versions of the same vaccines. This reflects the consultation with the Health Security Committee, ECDC, EMA and Member States regarding the use of the codes for the purposes of EU DCC.

If a country using the EU Digital COVID Certificate (“EU DCC”) decides to issue vaccination certificates to clinical trial participants during ongoing clinical trials, the vaccine medicinal product shall be coded following the pattern  
*CT\_clinical-trial-identifier*

Where the clinical trial has been registered in the [EU Clinical Trials Register](#) (EU-CTR), the clinical trial identifier from this register shall be used. In other cases, identifiers from other registers (such as clinicaltrials.gov or Australian New Zealand Clinical Trials Registry) may be used.

The clinical trial identifier shall include a prefix allowing the identification of the clinical trial register (such as EUCTR for EU Clinical Trials Register, NCT for clinicaltrials.gov, ACTRN for Australian New Zealand Clinical Trials Registry).

Where the Commission has received guidance from the Health Security Committee, the European Centre for Disease Prevention and Control (ECDC) or the European Medicines Agency (EMA) with regard to the acceptance of certificates issued for a COVID-19 vaccine undergoing clinical trials, the guidance shall be published either as part of the value sets document or separately.

In other cases, the vaccine marketing authorization holder or manufacturer shall be coded using the rule described under Section 2.3 Vaccine medicinal product (CT\_ *clinical-trial-identifier*).

## Annex A Summary of vaccine coding instructions

The table below shows the coding combinations of the different vaccine medicinal products with their recommended ATC or SNOMED CT 'Vaccine' concept, along with their corresponding marketing authorization holder or manufacturer. The table is included to assist implementation efforts.

As presented in the Value Sets above, for some vaccine medicinal products and marketing authorization holders or manufacturers, the applicable code is based on their names, using a hyphen to avoid blank spaces. Also, note, the comment included earlier for the Vaccine marketing authorization holder or manufacturer Value Set about the use of the OMS identifier of EU marketing authorization holder, as there is no internationally agreed coding.
