

Scientific Committee on Consumer Safety (SCCS) 15th Plenary meeting

30-31 March 2021

Minutes

1. Welcome and apologies, approval of the minutes of the previous plenary meeting/new agenda and declaration of interests

The Chair welcomed all participants, in particular the SCHEER representative and DG GROW F2 colleague. The agenda was adopted. Two apologies were received the first day and none the second day.

2.1 General information from GROW

2.2 New mandate(s)

1. The following mandates have been adopted by written procedure on 8 March and published on the website: https://ec.europa.eu/health/scientific_committees/consumer_safety/requests_en

- Four new mandates for endocrine disrupting (ED) substances from Group A (4-Methylbenzylidene camphor/4-MBC, Butylated Hydroxytoluene/ BHT, Kojic acid, Genistein and Daidzein)
- A new mandate for the revision of the Vitamin A Opinion

The rapporteurs selected by the SCCS have been appointed by the Commission.

2. SCHEER asked the SCCS for an additional representative in their new WG on TiO₂ in toys. The SCCS agreed.

- Gold (nano) -Colloidal Gold (nano) [, Gold Thioethylamino Hyaluronic Acid (nano) and Acetyl heptapeptide-9, Colloidal gold (nano)
- Platinum (nano) -Colloidal Platinum (nano) and Acetyl tetrapeptide-17 Colloidal Platinum (nano)

A progress report was provided on HAA-299 nano, which will be further discussed at the next April WG meeting.

Cosmetic Ingredients

A progress report was provided on:

- 1. **Methyl salicylate** (methyl 2-hydroxybenzoate). Tasks have been allocated to the members and a revised version of the draft preliminary Opinion will be discussed at the next April WG meeting.
- 2. **C054 hair dye**. The Applicant sent additional study to the SCCS that is still under assessment. Tasks have been allocated to the members and a revised version of the draft preliminary Opinion will be discussed at the next April WG meeting.
- 3. **Prostaglandin and analogues**. Relevant data are lacking. A draft preliminary Opinion will be discussed at the next WG meeting.
- 4. **Formadehyde releasers**. A first draft of the preliminary Advice will be prepared for discussion at the next April WG meeting.

Methodology

The Chair of the WG on methodology presented the final version of **the 11th Revision of the SCCS Notes of Guidance** (NoG). Last contributions received from the members were discussed and agreed on.

The whole NoG have been revised and updated with a particular emphasis on the following:

- Inhalation models
- o In silico methodology for genotoxicity/carcinogenicity
- o General updating of NAMs
- o Scientific concerns for the safety of the nanomaterials
- Update of ED section
- Discussion on uncertainty factors
- o Updating of references in general
- O Appendix 1: complying with the testing & marketing bans
- o Appendix 9: guidelines on microbiological quality of the finished product
- o Appendix 10: free access to in silico mutagenicity/genotoxicity databases
- o Appendix 11: inhalation parameterisation
- o Appendix 12: Lifetime Cancer Risk Approach
- o Appendix 13: PoD used for TTC derivation

The final document was adopted and will be published. There is no commenting period foreseen as this is an SCCS living document, regularly updated.

The SCCS Chair gave the floor for an update on the state of play of the following issues:

From the Commission

- The list of mandates/opinions for the SCs have been circulated
- PARC project: the 'framing' of this EU research project is ongoing. At this stage, upon request of the SCCS Secretariat, SANTE coordinator has approached DG RTD and ANSES-FR (lead PARC coordinators) to note the relevance of SCCS as a stakeholder.

- Cosmetics Europe (CoE) is planning to organise their annual event on 16 June via video/web. CoE invited the SCCS Vice-Chair to present changes in the 11th revision of the SCCS Notes of Guidance (NoG) and the SCCS Secretariat to discuss the situation/future of the work of the SCs. GROW is also invited to join.
