WG on Cosmetic Ingredients

1. WELCOME AND APOLOGIES

The Chair welcomed the participants. One apology was announced by the Chair.

2. ADOPTION OF THE AGENDA

The agenda was adopted as it was presented.

3. DECLARATION OF INTEREST ON MATTERS ON THE AGENDA

The Chair requested participants to declare any conflict of interest regarding matters on the agenda. None of the participants declared any conflict of interest.

4. INFORMATION FROM CHAIRMAN/MEMBERS/COMMISSION

- The Secretariat informed the members about a bilateral meeting held with the Secretariat of the Scientific Committee on Occupational Exposure Limits (SCOEL) to exchange information: the topic of common methodology approach between Scientific Committees and SCOEL is planned to be put on the agenda of the next ICCG¹ meeting on 16 November, together with the participation of SCOEL colleagues.
- On 15 June 2016 was held the Cosmetics Europe's Annual Meeting in Brussels: the new Committees and the revised SCCS Notes of Guidance for the testing of cosmetic ingredients and their safety evaluation were made by the Secretariat. The outcome of the week event will be made available soon on the website of Cosmetic's Europe.
- On 29-30 September, a member of SCCS will participate in the International Conference on Science Advice to Governments: "Science and Policy-Making: towards a new dialogue" in Brussels.

- On 15 June, the Commission endorsed two draft acts containing the scientific criteria to identify endocrine disruptors (EDs): one draft delegated act is under the Biocidal Products Regulation; and one draft Commission Regulation is under the Plant Protection Products Regulation, to be adopted in accordance with the regulatory procedure with scrutiny. The Commission also adopted a communication on endocrine disruptors, accompanied by a thorough impact assessment. All these documents are publicly available at the following webpage:

The comments received were presented and the tasks to help the rapporteur were distributed among members.

The comments received were presented. A clarification request has been sent to the applicant. The draft SCCS responses are planned to be further discussed at the next working group meeting (24/08).

- **HAIR DYES N,N'-BIS-(2-HYDROXYETHYL)-2-NITRO-P-PHENYLENEDIAMINE (B34)**

The comments received were presented. The draft SCCS responses are planned to be further discussed at the next working group meeting (24/08).
