Meeting of the Scientific Committee on Consumer Safety (SCCS) WG on cosmetic ingredients in Cosmetic Products

26 September 2017, Luxembourg

1. Approval of the agenda, minutes and declaration of interests

The Chair welcomed the participants.

The agenda was adopted.

The minutes of the previous meeting were already validated by written process by the WG members on 20 September and published on the website on 25 September 2017.

The Chair invited participants to declare any interest regarding matters on the agenda. None of the participants declared any interest conflicting with the matter on the agenda.

2. Nature of the meeting

This is a regular meeting of the working group.

3. List of points discussed and conclusions

3.1 New mandates

- The request for an Addendum to the scientific Opinion on the safety of the preservative Zinc Pyrithione P81 (additional toxicological studies) is still on hold as a clarification request was sent to DG GROW. The mandate is planned to be adopted at next plenary meeting (24-25/10) should the clarification is received.
- SCCS clarified with DG GROW that it can only assess studies/data submitted to answer a question mandated by the Commission and cannot, as such, advise on the design and conduct of a study. The applicant should consult the SCCS Notes of Guidance for that purpose.

3.2 Draft opinions:

• 2-(4-tert-butylbenzyl)propionaldehyde (BMHCA) – Submission II

The draft conclusions were discussed and a clarification has been requested to DG GROW before finalisation. A revised version is planned to be added on the agenda of

the next plenary meeting (24-25/10) for finalisation, provided that the clarification is received.

• Aluminium

The draft Opinion was discussed among members. DG GROW agreed to put the dossier "on hold" as Commission needs to first consider internally the next steps.

• <u>S86 UV-filter (Phenylene Bis-Diphenyltriazine)</u>

Question 1 from the mandate was corrected by DG GROW:" *In light of the new data provided, does the SCCS consider Phenylene Bis-Diphenyltriazine, S86 safe for use as a UV-filter in sunscreen products in a concentration up to 5.0%?*" (instead of 10%). The corrigendum has been published on the website. Rapporteur distributed tasks among colleagues to pursue with drafting of the Opinion.

• <u>Di-HEMA Trimethylhexyl Dicarbamate, HEMA and Urethane acrylates</u>

The draft opinion was reviewed and comments from the members discussed. A revised version is planned to be added on the agenda of the next plenary meeting (24-25/10) for further discussion.

• Quantitative Risk Assessment method (QRA 2)

A progress report was made as a last part is still under final revision. The draft opinion is planned to be added on the agenda of the next plenary meeting (24-25 October) for finalisation and possible adoption.

• Fragrance Vetiver Oil - Submission III

Following the SCCS request for clarification sent to the Applicant, the dossier is still on hold until the Applicant sends the information requested, expected to be by autumn.

3.3 Comments received on opinions adopted

• Water soluble zinc salts – SCCS/1586/17

A clarification has been requested to DG GROW before finalisation of the Opinion and the SCCS response to the comments received. It is planned to be added on the agenda of the next plenary meeting (24-25/10) for finalisation, should the clarification is received.

3.4 Update Information from Commission/Chair/Members

• SCCS prepared comments on the EU-ANSA 'research cluster' paper. The text of the paper is not finalised yet and EU-ANSA is planning to adopt the first version at its November meeting. SCCS requested to be associated, together with SCHEER, in the further drafting of this paper.

• SCCS Vice-chair, *Pieter-Jan Coenraads*, is planning to participate as observer in the third meeting of the International Dialogue for the Evaluation of Allergens (IDEA) Working Group on the feasibility of a study to assess the effectiveness of Quantitative Risk Assessment method - QRA.

4. Next steps

To collect all input from the members related to the revision of the draft opinions and to prepare respective new versions for both the next plenary meeting (24-25/10) and the next working group meeting (13 December 2017).
