Pilot project: Developing evidence based strategies to improve the health of isolated and vulnerable persons

- Supports the development of actions to address the health needs (both physical and mental) of people living in isolated and vulnerable situations in the EU.
- Focus on those living in more (geographically and socially) isolated communities
- Identifies differences for men's and women's health needs



Specific objectives

- Assessment of the situation
- **Exchange of information**
- Capacity building and training
- **Dissemination of project results**



Information exchange/dissemination

- **Building an expert group**
 - Facilitating the exchange of information
 - Establishing links
 - Expert groups on social determinants and health inequalities and on mental health
 - Joint Action on Mental Health and Well-being, and the Joint Action on Chronic Diseases and Healthy Aging
 - Developing a policy guidance
 - Dissemination via stakeholder groups (expert groups, joint actions)
