on the adoption of a financing decision for 2015 on the pilot project "The Effect of Differing Kidney Disease Treatment Modalities and Organ Donation and Transplantation Practices on Health Expenditure and Patient Outcomes"

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and repealing Council Regulation (EC, Euratom) No 1605/2002¹, and in particular Article 84(2) thereof,

Whereas:

- (1) Article 54(2)(a) of Regulation (EU, Euratom) No 966/2012 foresees that, by way of derogation from Article 54(1) of that Regulation, appropriations for pilot projects of an experimental nature designed to test the feasibility of an action and its usefulness may be implemented without a basic act provided the actions which they are intended to finance fall within the competences of the Union.
- (2) In the European Union budget for 2015, the Budgetary Authority allocated EUR 1 000 000 for a pilot project in the field of "The Effect of Differing Kidney Disease Treatment Modalities and Organ Donation and Transplantation Practices on Health Expenditure and Patient Outcomes".
- (3) In order to ensure implementation of the pilot project "The Effect of Differing Kidney Disease Treatment Modalities and Organ Donation and Transplantation Practices on Health Expenditure and Patient Outcomes" it is necessary to adopt a financing decision and the work programme for 2015. Article 94 of Commission Delegated Regulation (EU) No 1268/2012² establishes detailed rules on financing decisions.
- (4) It is necessary to allow the payment of interest due for late payment on the basis of Article 92 of the Regulation (EU, Euratom) No 966/2012 and Article 111(4) of Delegated Regulation (EU) No 1268/2012,

HAS DECIDED AS FOLLOWS:

Article 1
The work programme

The annual work programme for the implementation of the pilot project “The Effect of Differing Kidney Disease Treatment Modalities and Organ Donation and Transplantation Practices on Health Expenditure and Patient Outcomes” for 2015, as set out in the Annex, is adopted.

The annual work programme constitutes a financing decision within the meaning of Article 84 of the Regulation (EU, Euratom) No 966/2012.

Article 2
Union contribution

The maximum contribution for the implementation of the pilot project for the year 2015 is set at EUR 1 000 000 and shall be financed from the following line of the general budget of the European Union for 2015:

budget line 17 03 77 16: EUR 1 000 000

The appropriations provided for in the first paragraph may also cover interest due for late payment.
