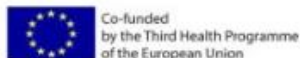

WP4 Objectives (from GA)

- General objective
 - To support Member States on the implementation of new or innovative policies and practices for empowerment, health promotion and prevention, management of chronic diseases and multimorbidity.
- Specific objectives:
 1. To support the development and adoption of national, regional and local policies related to health promotion, prevention and innovative management of chronic diseases in their various settings through policy dialogues.
 2. To support sustainable action planning of Member States to tackle chronic diseases
 3. Reach consensus of a final position paper (“Consensus Statement”) concerning the EU added value of cross-country collaboration in the field of health promotion and prevention and management of chronic diseases and the sustainability of the results from JA-CHRODIS and CHRODIS-PLUS beyond 2020.

Task 4.4: Consensus Statement and Report on the Integration in National Policies and Sustainability (from GA)

Task: To prepare a consensus statement concerning

1. the EU added value of **cross-country collaboration** in the field of CD
2. and the **sustainability** of JA-CHRODIS and CHRODIS-PLUS beyond 2020.

Functional requirements

A. The document will

- be based on **lessons-learnt** from the JA-CHRODIS,
- making use of the inputs and **conclusions from others tasks** of the WP4,
- and other **WPs outputs** of CHRODIS-PLUS.

B. The Document must include **an analysis** on

1. the **integration** in national policies
2. **sustainability** of JA-CHRODIS and CHRODIS-PLUS proposals beyond 2020.
3. MS Priorities on CDs control after 2020

C. The document will also include a Consensus Statement proposal concerning the **EU added value of cross-country collaboration** in the field of CD.

Opportunity for all: why do we need MS?

- **To gather their needs and perspectives**

Time planning



- **February '19 : presentation to SGPP**
- **Before Summer '19: MS e-survey ; first meeting (Webinar) in order to gather inputs (content of the sections andsources); definition of on-line tools**
- **September '19: Draft structure ready (SGPP consulted on-line)**
- **October '19: First draft ready for circulation among SGPP**
- **November '19: Ad hoc meeting (back to back with SGPP)**
- **By January-February '19: Final draft ready**
- **Spring '20: Endorsement by SGPP**





This **survey** includes questions on:

- the **priority areas** in the policy agenda from MS (Section 1)
- the **solutions** that are more relevant for giving added value to the EU collaboration among MS which enable the integration and sustainability of NCD good practices into the national/regional policies/practices (Section 2)

Then, SGGP members will be involved in a face-to-face meeting (next November)

- to discuss the survey results;
- To draft the Consensus Statement.

The survey aims to gather input from SGPP members and will be focused on:

1. Priority action areas - **to prioritize the policy key areas** based on EU Council conclusions on the field of NCD.
2. Sustainability, integration on national policies and EU added value - **to rank the effectiveness of the solutions** highlighted in the framework.
3. Operational advices and suggestions - **to provide advices and suggestions** based on Country experience in implementing those solutions.

We expect to receive **one filled in questionnaire for each Member State**. The gathered information will represent the point of view of the Country and not the opinion of the filler

FOLLOW UP (Sep-Oct 2019)

After the closing of the survey, we will analyze the answers and, on the base of the results, we will draft a very first version of the consensus statement to present to the SGPP meeting in November. In this stage, your collaboration and active participation is welcome.
