 This proposal has been received by ECHA in May 2016 and is still under evaluation by Risk Assessment Committee (RAC) in ECHA. Comments on the proposal have been received until 15/07/2016.
- Commission Regulation (EU) 2016/1120 amending Annex IV to Regulation (EC) No 1223/2009 of the European Parliament and of the Council on cosmetic products (Carbon Black) has been adopted on 11 July 2016 and published in the OJ L187 of 12.07.2016, p. 1.
- Commission Regulation (EU) 2016/1143 amending Annex VI to Regulation (EC) No 1223/2009 of the European Parliament and of the Council on cosmetic (TiO2) has been adopted on 13 July 2016 and published in the OJ L189 of 14.07.2016, p. 40.
