The European Cancer Inequalities Registry

Dear participant,

The European Cancer Inequalities Registry, a flagship initiative of Europe's Beating Cancer Plan, was launched on 2 February this year. The European Cancer Inequalities Registry provides sound and reliable data on cancer prevention and care, with the aim to identify trends, disparities and inequalities between Member States and regions. In highlighting challenges and specific areas of action, it helps guide investment and interventions at EU, national and regional level under Europe's Beating Cancer Plan.

The Registry consists of three elements: (1) a data tool, which is already available now, (2) reports focusing on the assessment of the country-specific situation, which will be published in even years, and (3) an analytical report comparing performance at EU level, published in odd years.

The data tool currently presents inequalities due to gender, educational attainment and income level, as well as disparities between urban and rural areas in cancer prevention and care. This new tool will be continuously updated and further enhanced to reflect a range of inequalities and include relevant indicators from additional sources.

The purpose of this webinar is to present the online data tool of the European Cancer Inequalities Registry.
