- The members were informed on the ongoing working group of SCENIHR on sunbeds and on the status of the draft Opinion.
- HEARINGS the SCCS met with the industry representatives and reported on nano silica on 4 December. It will also meet with applicant of BMHCA fragrance ingredient on 16 December.
- A DG GROW Workshop on cosmetic product preservation was held on 21 October in Brussels. SCCS representatives and Secretariat were participating and Werner Lilienblum, SCCS member, reported on the event highlighting the importance of the quality of a safety dossier to start a risk assessment. GROW D4 reported on DG GROW Workshop on cosmetic product preservation explaining the foreseen follow-up actions
- Werner Lilienblum, SCCS member,, reported on the JRC meeting of "The read-across case study for safer assessment contributing to the SEURAT-1 Proof in Concept Part II" held on 5-6 October. The project will end in December 2015 and final results will be presented in Brussels.
- *Tamara Vanhaecke*, SCCS external expert, participated in the JRC meeting of the preliminary assessment of regulatory relevance Network (PARERE) on 20-21 October 2015. Her report was already sent to all SCCS members.
- *Pieter-Jan Coenraads*, SCCS member, participated in ECVAM stakeholders' meeting and also in IDEA Workshop on pre- and pro-haptens in Brussels on 20-21 October 2015 and reported on both events.
- *Christophe Rousselle*, SCCS member, participated in the Benchmark Dose (BMD) meeting in EFSA on 4-5 November 2015. His report was already distributed to all SCCS members. This topic is planned to be further discussed at next methodology WG meeting on 15 March 2016.
- Christophe Rousselle, SCCS member, participated in the Commission workshop to
  present methodology for evidence screening of chemicals developed by the JRC in the
  context of an impact assessment (IA) on criteria to identify Endocrine Disruptors
  (EDs), on 6 November 2015. His report was already distributed to all SCCS members.
  The European list of EDs has been published and 45 cosmetic ingredients have been
  selected:

- SCCS Opinions on Aluminium, TiO2 (nano), Polyaminopropyl Biguanide (PHMB), Silica (nano), and beta alpha and deoxyarbutin have been published in the Regulatory Toxicology Pharmacology Journal. The two last ones for 2015 are planned
