

Scientific Committees on Health, Environmental and Emerging Risks (SCHEER) 1st Plenary meeting 2022-2026

25 March 2022, Luxembourg (AUDIO)

Minutes

1. Welcome and apologies, approval of the agenda and declaration of interests

The Secretariat welcomed the participants. Three apologies have been received.

The agenda was adopted without changes.

The Secretariat invited participants to declare any interest regarding matters on the agenda. None of the participants declared any new interest conflicting with the matters on the agenda.

The Chair of the term 2016-2021 resigned. The Secretariat presented the suggested members as candidates and performed anonymous voting for the election of the new chair.

2. Points for discussion/decision

2.1. New draft mandates (adoption planned in June)

- The EU environmental foresight system (FORENV) by DG ENV is a process for detecting, characterising and prioritising emerging environmental issues. The main objective is to enable EU policy makers and other stakeholders to exploit emerging opportunities and to manage risks. Various partners involved (Commission services, external experts, scientific committees, contractor). Cycle 4 is starting in 2022 and a short list of 10 issues will be set by mid-May 2022. The SCHEER will receive a mandate in June plenary to confirm selected emerging issues as the right ones, to check if there is any additional issue omitted, to inform about plausible timeframe of emergence, and to qualitatively assess their impacts on human health and environment. The deadline is planned by October 2022. FORENV workshops will be held on 5 and 7 of April: 5 SCHEER members are planning to participate.
- O Draft mandate for SCHEER Opinion for an opinion in support of a targeted revision of Annexes III (accommodation and care of animals) and IV (allowed killing methods) of Directive 2010/63/EU on the protection of animals used for scientific purposes by DG ENV (fully revised in 2010, and further amended in 2019 including 3Rs: replace, reduce, refine). SCHEER will receive a mandate in June plenary with specific questions covering key accommodation parameters for zebrafish, housing requirements for birds kept in captivity and killing method for zebrafish. External experts might be requested to join members in a specific WG. The deadline may have to be expanded to the end of the first quarter 2023.

2.2. Opinions for adoption

SCHEER opinions on environmental quality standards for water framework directive:

The rapporteur presented the final texts to the SCHEER members.

The SCHEER has technically adopted the documents, taking into account last comments made during the meeting.

SCHEER Opinion on cobalt in toys

The Chair of the WG updated the SCHEER on the state of play of the draft Opinion. The next meeting of the WG is planned on 4 April 2022.

SCHEER WG on Rapid Risk Assessment

The Chair reported on the recent request from the Commission asking who from the Pool of Experts of this WG (put on hold) would be available and interested to join an internal EU task force to work further on rapid risk assessment issues.
