

# EXPERT GROUP ON TOBACCO CONTROL MEETING OF THE SUBGROUP ON TRACEABILITY AND SECURITY FEATURES

#### - SUMMARY RECORD -

**Date:** 29 June 2022

**Location:** Hybrid meeting (video-conference & physical meeting at EC premises)

#### 1. Welcome and introduction

The Chair welcomed the participants, reminded them about the basic rules as to participation in discussions via video-conference and introduced the meeting's agenda as well as its indicative timing. The Subgroup approved the agenda.

SANTE presented the latest system users' and supply chain coverage's statistics to the Subgroup. Then, they updated the Subgroup on the latest developments concerning the signature of the Joint Controllership Arrangement and its implementation. SANTE congratulated the Member States that signed the Arrangement, and invited the other Member States to sign the text in line with their data protection obligations as joint controllers.

The Subgroup was also updated on the latest developments concerning the project on the preparation of an expert study on the development and configuration of automatic alerts to be generated by the repositories system of the EU tobacco traceability system.

Finally, SANTE announced the new ID Issuer appointed by UK and clarified that this change that has an impact on the market of Northern Ireland, has been reflected in the relevant ID Issuers' tables that are published on the Commission website for the tobacco traceability system.

## 2. Discussion on the proposed revision of Commission Implementing Regulation (EU) 2018/574

SANTE explained the reasons for the proposed targeted revision of Commission Implementing Regulation (EU) 2018/574, the general procedure for the adoption of Implementing Acts and an indicative timeline for the adoption of the amending Implementing Regulation.

SANTE stressed that the version of the draft Implementing Regulation that was shared with the Member States before the meeting of the Subgroup, is still subject to the formal validation by other Commission services and as a result, certain provisions may change.

SANTE presented all the proposed amendments to Commission Implementing Regulation (EU) 2018/574 together with the relevant rationale for them. The Subgroup discussed the proposed amendments with SANTE and was also invited to submit their written remarks on the text of the draft Implementing Regulation after the meeting.

#### 3. AOB including communication from the Member States

One Member State presented certain enforcement actions that were taken against tobacco companies at national level. SANTE stressed the importance of the enforcement activities for the proper functioning of the T&T system and the relevant exchange of views on these activities during the Subgroup meetings. The Subgroup discussed the case at hand.

#### 4. Closing remarks

The Chair summarised the discussion on the proposed targeted revision of Commission Implementing Regulation (EU) 2018/574, thanked the participants for their active contribution to the meeting and looked forward to the next meeting in October 2022.
