#### SPECIFIC PRIVACY STATEMENT

Call for expressions of interest as members of the Scientific Committee on Consumer Safety and of the Scientific Committee on the Health, Environmental and Emerging Risks (non-food Scientific Committees of the European Commission) for the term 2016-2021

#### 1. Context and Controller

As the Commission service collects and further processes personal data, it is subject to Regulation (EC) 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data.

The objective of the Call is to invite applications from experts from the European Union and elsewhere to become members in the following non-food Scientific Committees of the European Commission:

- the Scientific Committee on Consumer Safety (hereinafter 'SCCS') or
- the Scientific Committee on Health, Environmental and Emerging Risks (hereinafter 'SCHEER').

Scientific Committees' members are appointed in their personal capacity, for a term of 5 years starting in April 2016.

The mission of the Scientific Committees is to provide the Commission with high quality and independent scientific advice for risk assessment in the areas of public health, consumer safety, and environmental risks, including assessment of research needed in the future.

Processing operations are under the responsibility of the Head of Unit C2- Health Information and Scientific Committees, of the Directorate-General for Health and Food Safety acting as Controller as indicated in the Call to renew membership in the non-food Scientific Committees of the European Commission for the term 2016-2021.

# 2. What personal information do we collect and for what purpose? Which is the legal basis?

Processing is based on Article 168 of the Treaty on the Functioning of the European Union and on Commission Decision C(2015)5383 on establishing Scientific Committees in the field of public health, consumer safety and the environment.

Processing is lawful in accordance with Article 5(a) and (b) of Regulation (EC) No 45/2001, since it is necessary for the performance of a task carried out in the public interest on the basis of the Treaties.

For the purposes of drawing up a list of candidates and for the management and administration of the selection of experts (including the provision of evidence of technical and professional capacity), the following personal data are collected and further processed under the responsibility of the Controller at the Commission:

# 2.1 Application form

The application form mainly collects identification data and contact information of applicants in the Call, together with data on the applicants' language knowledge, current employer, qualifications, professional and scientific experience.

This information is necessary to select the most suitable candidates to fill the position of members of the Scientific Committee and to ensure that they have the competence to support the Commission, by providing independent and sound advice for risk assessment in the areas of public health, consumer safety, and environmental risks, including assessment of research needed in the future.

#### 2.2 Declaration of interests form

The declaration of interests form collects data concerning the applicant's professional career (direct or indirect interests such as research funding, consultancies, etc.), private interests (membership or affiliation, investments, etc.) and interests of close family members.

# 2.3 Other documents included in the application

The application must include a Curriculum Vitae and a list of publications. Applicants may be requested to provide supporting documents at a later stage.

# 3. Through which technical means are personal data processed

Your personal data is provided by submission of your expression of interest.

The information is collected in files stored in an isolated secure system (database). The information is processed by Commission personnel and transferred (as described in point 6) to Commission systems, under the responsibility of the Controller.

#### 4. Who has access to your personal data and to whom is it disclosed

Access to your personal data is given to staff members in the Controller's unit responsible for managing the Call and Commission services involved in the evaluation, without prejudice to a possible transmission to the bodies in charge of a monitoring or inspection task in accordance with European Union law (European Court of Auditors, the Internal Audit Service, OLAF, the European Ombudsman and the European Data Protection Supervisor).

The personal data (names, CV, declarations of interests, of confidentiality and of commitment) of the selected members of the Committees will be published on the Scientific Committees website.

Some of your personal data (listed in the Notification DPO-2194 Register of Expert Groups and Other Similar Entities, see in the DPO Public Register: http://ec.europa.eu/dpo-register/search.htm) will be made publicly available in the Register of Expert Groups and Other Similar Entities (http://ec.europa.eu/transparency/regexpert/) for as long as the membership upholds and/or until removal from the public site is requested.

#### 5. How do we protect and safeguard your information?

The collected personal data and all information related to the above mentioned activities are stored on the European Commission servers, the operations of which abide by the Commission's security decisions and provisions established by the Directorate of Security for this kind of servers and services.

Appropriate measures are in place in accordance with Articles 22 and 23 of Regulation (EC) No 45/2001, in particular to protect the data provided by applicants against possible misuse by internal or external persons.

# 6. How can you verify, modify or delete your information?

In case you want to have access to your personal data or to have them rectified, blocked or erased in the cases referred to under Articles 13, 14, 15 and 16 of Regulation (EC) No 45/2001, you should contact the responsible Controller by using the "Contact information" provided under Section 8 below and by explicitly stating your request. Legitimate requests will be replied by the Controller within 10 working days as from receipt of the request.

Any correction of your personal data will be taken into consideration from the data protection point of view.

### 7. How long do we keep your personal data?

Files relating to the selection of experts including personal data are to be retained by the service in charge of the procedure until the end of the term of the Committees for which the expressions of interest were submitted (end 2021), and in the archives for a period of 5 years following the end of that Committee's term.

#### 8. Contact information
