1. WELCOME AND APOLOGIES

Prof. Greim, Chair of the Committee, opened the meeting and welcomed the participants.

Apologies received from C. Janssen, J. Tarazona, and D. Bard (J. Davison resigned from the Committee)

2. ADOPTION OF THE DRAFT AGENDA

The updated draft agenda was adopted as proposed.

3. DECLARATION OF INTERESTS ON MATTERS ON THE AGENDA

One member declared her past affiliation with Rhodia (AG) which is related to the new mandate 6.3 (please see below). In relation to the same mandate, two other members (H. Greim and P. Calow) also declared their association with the REX Panel of the Research Institute for Fragrance Materials. Neither of these declarations was deemed as conflicting by the Committee.

4. APPROVAL OF THE MINUTES OF THE PREVIOUS PLENARY MEETING

The minutes of the 9th SCHER plenary meeting were adopted after a correction on the attendance list (E. Testai was absent)

The responsible desk officer from DG ENTR (A. Pantazi) explained the request in detail. After a short discussion, it was decided to:

- 1. Drop the third question from the mandate because of its scope which was deemed too wide and requiring an enormous amount of effort. DG ENTR is to submit on a case-by-case basis requests for specific substances.
- 2. Add a sentence to the first two questions of the mandate which will make the exercise more holistic: "and consider potential halogenated alternatives".
- 3. The members of the new working group were determined.
- 4. The first meeting will be held on either 1st or 2nd December.
- 5. The second meeting of the WG will be held on either 1st or 9th December.
