Cooperation with Horizon 2020

Particular focus has been given to reinforcing the coordination and improving the synergies with the Horizon 2020 Research Programme towards actual implementation of the research results for the benefit of the EU citizens and health systems.



Cooperation with Horizon 2020

This is a pilot for the approach for further articulation of the Health Strand of ESF+ with Horizon Europe and with other relevant financial instruments defined in the Multiannual Financial Framework to ensure that human health is protected across all policy areas.

This document is not an official document formally approved by the European Commission; it describes potential priorities identified by DG SANTE for the preparation of the Annual Work-Program 2020 of the Health Program.



Potential Priorities - Health Information

Health Information in 2020; SANTE will strive to

- *Create an **ERIC on Health Information** with a view to building a sustainable health information system in the EU.*
- *Create a uniform frame for implementation and use of existing data including registries and other national data sources to best serve health research and policy needs.*



Potential Priorities - Health threats

- *Vaccination prioritization; increase vaccine confidence and coverage, sustainable policies and EU coordination.*
- *AMR; further actions as planned in the roadmap on the implementation of the Action Plan*
- *Blood, tissues & cells; support actions to follow-up on issues identified in the evaluation of the legislation on.*



Potential Priorities - Prevention

- *Support to Member States priorities and initiatives in the areas of rare diseases, mental health and diabetes.*
- *Implementation and enforcement of the Tobacco Products Directive through further implementation of the ingredients regulation and a dedicated Tobacco Eurobarometer*



Potential Priorities - Health systems

- *foster knowledge brokering and Member State collaboration for accelerating and for reinforcing convergence*
- *capacity building activities (e.g. "twinning projects", service contracts for technical support action, or OECD work to conduct capacity building exercises for the Member States).*



Potential Priorities - Digital technologies

- *Analysis of the policy and/or regulatory challenges resulting from the integration of digital technologies in healthcare systems*
- *Joint Action on investment in the digital infrastructure*
- *Economic analysis of the ERN system*
- *Development of an effective strategy and actions on e-training, e-learning and education in ERNs.*



Potential Priorities - Pharmaceuticals

- *Analysis of the interactions between the regulations on Pharmaceutical products and other sectors such as Medical devices.*
- *Support to initiatives concerning "repurposing" of existing medicinal products*
- *Analysis of possibilities to create electronic product information for patients*
- *Activity/activities to bridge the unavoidable gap between EUNetHTA and the application of the new legislative framework*
