Service Contract (Procurement) vs. Project Grant

To acquire a product or a service.	Purpose	To encourage actions indicated in the Work Plan, which fall primarily within the scope of the beneficiary's activities		
Call for tender	Procedure	Call for proposals		
Service Contract	Legal outcome	Grant Agreement		
The EU pays 100 % of the contract price	EU financial contribution	EU-contribution to the overall costs (Co- funding)		
Since the service or product has been purchased and paid for by the EU, in general it belongs to the EU in its entirety	Ownership	The ownership as a rule is vested in the beneficiary of the grant.		
The operator's remuneration should include an element of profit.	Profit	The grant must not have the purpose or the effect of producing a profit for the beneficiary.

Principles


Definition: a grant is a direct financial contribution to an action or functioning of a body


- Co-funding rule: external co-financing from a source other than EC funds is required (own resources or financial contributions from third parties, project income)
- Non-profit rule: the grant may not have the purpose or effect of producing a profit for the beneficiary
- Non-retroactivity rule: only costs incurred after the starting date stipulated in the grant agreement can be co-funded
- Non-cumulative rule: only one grant can be awarded for a specific action carried out by a given beneficiary

Structure of the Project Proposal





Specifics

- Owner of the outcome is the consortium (IPR, consortium agreement obligatory)
- Flexibility of shaping the content in the frame of the call
- Contribution of 60/80% to the real costs, based on the estimated budget, initial pre-financing
- No profit
- Consortium Visual Identity for publications
- At least 3 Organisations from at least 3 EU MS, plus participating countries
- Full electronic lifecycle and project administration










What is procurement? EU Purchases - Public Procurement = Call for tenders





Certain non EU countries as follows:

- With special agreement in the field of public procurement with the EU
- Under the Stabilisation and Association Agreements (FYROM, Albania, Montenegro, Serbia, Bosnia and Herzegovina, Kosovo)
- European Economic Area (Norway, Iceland and Liechtenstein)
- GPA Parties (only in case of interinstitutional procurement)


Types of tenderer:

- Single tenderer
- Single Tenderer with Subcontractor
- **Consortium**
- Consortium with Subcontractor



Submission - 3 envelops

The Tender must include 3 envelopes:




The offer has to be sent to Chafea by registered mail or by courier post mail, in a sealed packet containing the 3 envelops, before the date of deadline.





Procedure Open Call for Tenders





Specifics

- Transparent economic operation
- Owner of the outcome is EU/EC
- Tender specifications are "specific", offer must comply in detail
- Pre-existing rights need to be transferable
- Payment of an agreed price against invoice, no prefinancing
- Contractor can make profit/loss
- European Commission Visual Identity for publications
- 1 up to many partners, also
- Paper submission, Paper contract, paper invoice.

- Similarities:
 - Public competition
 - Selection and Award Criteria are published
- Differences
 - Content flexibility
 - Financial principle (Contribution vs. Price)
 - Intellectual Property Rights (Owner of the product)
 - Consortium structure and agreements
 - Electronic vs. Paper submission and contracting
 - External vs. Internal Evaluation
