

ERIC - European Research Infrastructure Consortium (Council Regulation (EC) No 723/2009 of 25 June 2009)



- A **legal instrument** at EU level, to facilitate the joint establishment and operation of RI of European interest.
 - Legal personality recognized in all Member States
 - Qualifies as an international organization for the purposes of VAT (exemption under certain limits and conditions from VAT and excise duties) and Public Procurement Directives



ERIC Regulation

 Adopted in 2009 by Council to facilitate the joint establishment and operation of Research Infrastructures of European interest among several countries and amended in December 2013 to better reflect contributions of associated countries in particular in terms of voting rights

•An ERIC is not a Union Body and the Commission Implementing Decision is not a funding decision

•First Report on the application of the ERIC Regulation was adopted by the Commission on 14 July 2014 COM(2014) 460 final and transmitted to Council and European Parliament



ERIC Regulation

- •An easy-to-use legal instrument providing:
- •the spirit of a truly European venture
- •a legal personality recognized in all MS
- Intersection of each research infrastructure
 Intersection
- •some privileges / exemptions allowed at a national level similar as for intergovernmental organisations
- •a lighter process than creating an international organisation



ERIC Regulation

•Article 187 TFEU (ex-171 EC Treaty)

The Community may set up joint undertakings or any other structure necessary for the efficient execution of Community research, technological development and demonstration programmes.



ERIC Tasks and Requirements

- Principal task: establish and operate a Research Infrastructure, on a non-economic basis (limited economic activities are however possible)
- Five requirements to be met:
- necessary for European research
- added value in the development of ERA and significant improvement in relevant S&T fields
- •effective access to European researchers
- contributes to the mobility of knowledge and/or researchers within the ERA
- •dissemination / optimization of the RTD results



HORIZON 2020

Membership of an ERIC

- Member States Associated Countries Third States Intergovernmental organisations
- Minimum requirement of one MS with two other MS or AC for establishing or having an ERIC
- Always majority of MS and/or AC for votes in the General Assembly
- •For an ERIC hosted by MS, amendments of Statutes shall require agreement of majority of MS member of that ERIC
- •A State may be represented by one or more public entities or private entities with a public-service mission



Internal Structure of an ERIC

- statutory seat in a Member State or Associated Country; research locations anywhere
- •mandatory bodies (General Assembly; Director/Board of Directors)
- •members' liability may be limited to committed contribution, no capital requirement
- •may specify in the Statutes a fixed liability above their respective contributions or unlimited liability
- In case of limited liability insurance is mandatory



Public Procurement and VAT

- •ERICs may set their own procurement rules based on transparency, nondiscrimination and competition.
- •ERICs are exempted from paying VAT and excise duty.
- This is possible because ERICs are considered as international bodies/ organisations for the purposes of the Directives on public procurement, VAT and excise duties.



Law applicable to the internal functioning of an ERIC

Union law, in particular the ERIC Regulation

- •the law of the State where the ERIC has its statutory seat
- The ERIC's statutes and its implementing rules



Application process

- •Governments and int. Org. which want to be members of a future ERIC agree on:
- technical description of the RI
- recognition of tax exemption as int.org/body by host
- Imits and conditions of tax exemptions
- Provisions of the Statutes
- •If members outside EU: recognition of legal personality and tax exemptions in the countries which want to be member of the ERIC

Dear Madam, Sir,

Re: Accession to SHARE-ERIC

- The State of Israel represented by the Ministry for Senior Citizens in view of its application for membership of SHARE-ERIC declares, in accordance with Article 9(5) of Regulation (EC) No 723/2009 of 25 June 2009 on the Community Legal Framework for a European Research Infrastructure Consortium (the "ERIC Regulation"), that:
 - (a) SHARE-ERIC shall have legal personality and capacity under the laws and regulations of the State of Israel in accordance with Article 7(1) and (2) of the ERIC Regulation;
 - (b) Its participation in Share-ERIC shall be subject to rules determined in application of Article 15 of the ERIC Regulation.
- The State of Israel shall accord to SHARE-ERIC treatment equivalent to that following from:
 - (a) Article 5(1)(d) of the ERIC Regulation subject to the limits and conditions laid down in an agreement between the members of SHARE-ERIC; and
 - (b) Article 7(3) of the ERIC Regulation.
- This Declaration shall bind the State of Israel from the time of its entry into force pursuant to paragraph 4, and for as long as it remains a member of SHARE-ERIC.

Application process (Step 1)

- Commission verifies completeness of application
- •If application complete:
- •With support of independent experts verify whether the Research Infrastructure complies with Article 4 of the Regulation (scientific relevance, effective access, etc.)
- •Examines compliance with the administrative requirements (minimum Member States, statutes contain all necessary elements, etc.)
- •Applicants are informed by the Commission of outcome of the assessment and are invited to modify their application taking into account the feedback received.



Application process (Step 2)

- •Formal application in which the members commit to the Statutes and the financial provisions
- Formal Opinion of the ERIC Committee requested
- Commission internal procedure to arrive at a Commission Implementing Decision establishing the ERIC
- •Publication of the Implementing Decision and the Statutes in the Official Journal of the European Union
- •ERIC Implementing Decision enters into force on the third day following the publication in the Official Journal of the European Union

COMMISSION IMPLEMENTING DECISION

of 22 November 2013

on setting up the Biobanks and Biomolecular Resources Research Infrastructure Consortium (BBMRI-ERIC) as a European Research Infrastructure Consortium

(2013/701/EU)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EC) No 723/2009 of 25 June 2009 on the Community legal framework for a European Research Infrastructure Consortium (ERIC) (¹), and in particular point (a) of Article 6(1) thereof,

Whereas:

- (1) The Kingdom of Belgium, the Czech Republic, the Federal Republic of Germany, the Republic of Estonia, the Hellenic Republic, the French Republic, the Italian Republic, the Republic of Malta, the Kingdom of the Netherlands, the Republic of Austria, the Republic of Finland and the Kingdom of Sweden requested the Commission to set up BBMRI as a European Research Infrastructure Consortium (BBMRI-ERIC). The Kingdom of Norway, the Republic of Poland, the Swiss Confederation and the Republic of Turkey will participate in BBMRI-ERIC as Observers.
- (2) The Republic of Austria has been chosen by the Kingdom of Belgium, the Czech Republic, the Federal Republic of Germany, the Republic of Estonia, the Hellenic Republic, the French Republic, the Italian Republic, the Republic of Malta, the Kingdom of the Netherlands, the Republic of Finland and the Kingdom of Sweden as the Host Member State of BBMRI-ERIC.

(3) The measures provided for in this Decision are in accordance with the opinion of the Committee established by Article 20 of Regulation (EC) No 723/2009,

HAS ADOPTED THIS DECISION:

Article 1

 A European Research Infrastructure Consortium for the Biobanks and Biomolecular Resources Infrastructure named BBMRI-ERIC is hereby established.

 The statutes of BBMRI-ERIC are set out in the Annex. These Statutes shall be kept up to date and made publicly available on the website of BBMRI-ERIC and at its statutory seat.

 The essential elements of BBMRI-ERIC Statutes for which amendments shall require approval by the Commission in accordance with Article 11(1) of Regulation (EC) No 723/2009 are provided for in Articles 2, 3, 6, 7, 16, 17, 18, 19 and 24.

Article 2

This Decision shall enter into force on the third day following its publication in the Official Journal of the European Union.


Lifewatch (Spain)

2010 ESFRI Roadmap



ERIC Implementation

- Until now all established ERICs concern distributed RIs
- •Two ERICs- CERIC and JIV- not part of the 2010 ESFRI Roadmap
- Around 20 MS and associated countries are involved in ERICs as members or observers
- •ERICs are hosted until now in 6 MS; Netherlands (CLARIN, EATRIS and when established JIV), Germany (SHARE), France (ECRIN, Euro-Argo, DARIAH), Austria (BBMRI), UK (ESS) and Italy (CERIC)
- •Future adoption of ICOS (Finland), EMSO (Italy), Lifewatch (Spain) and European Spallation Source (Sweden) would result in 9 MS hosting ERICs and include a first single site RI (European Spallation Source)
