Managing antimicrobial resistance across the health system

Monday 20 June 2022, 10.00 – 12.00 CEST, Brussels time

Dear colleague,

We invite you to join the webinar "Hearing of the Expert Panel on effective ways of investing in health on the draft opinion on managing antimicrobial resistance across the health system" on Monday 20 June 2022 from 10.00 to 12.00 CEST.

Description of the webinar: EU action on antimicrobial resistance (AMR) has been on the policy agenda for many years. A wide range of measures has been put in place to fight AMR and promote a more prudent and responsible use of antimicrobials in humans and in animals. It is important to note that AMR is a cross-sectoral issue and needs to be addressed at all levels and across all of the One Health dimensions, acknowledging the interlinkages between humans, animals, plants and the environment. However, there are still challenges in effective implementation of AMR policies across health systems.

The Expert Panel's report will identify the necessary systemic elements, conditions and interventions of effective management of antimicrobial resistance (AMR) across, but also beyond, the health systems that could translate into effective policy interventions. It will elaborate how new technologies (e.g. digital apps, in vitro diagnostics) could help tackle AMR in health systems, what investments are urgently needed and what strategies can be recommended to Member States to implement existing and planned policies to tackle AMR.

The aim of this hearing is to provide stakeholders with an opportunity to share their views on the draft opinion of the Expert Panel on the above-mentioned subject. The draft opinion will be available at the Expert Panel website prior to the hearing.
