• S86 UV-filter (Phenylene Bis-Diphenyltriazine)

A second request for additional information was sent to the Applicant. The draft Opinion was discussed and data is still under assessment. The revised draft Opinion will be discussed at the next meeting on 24/01/18.

# • Fragrance Vetiver Oil - Submission III

The requested additional data was received just before the last plenary meeting (24-25/10) and was discussed. The revised draft Opinion will be discussed at the next meeting on 24/01/18.

# • Di-HEMA Trimethylhexyl Dicarbamate, HEMA and Urethane acrylates

The preliminary Opinion was discussed and finalised. It will follow a written procedure for adoption after the meeting and editing before publication.

# • A165- Hydroxypropyl P-Phenylenediamine

A progress report was made and tasks allocated among members. A request for clarification was sent to the Applicant. The draft Opinion will be discussed at the next meeting on 24/01/18.

The preliminary Opinion was going through written procedure for adoption before the meeting in order to be adopted on 14 December. It will go through editing prior to publication.

# • Aluminium in cosmetic products - Submission II

DG GROW informed SCCS that an additional study will be submitted by the Applicant by November 2018. The dossier is therefore **on hold**.

#### 2.3 Comments on opinions

• Water soluble zinc salts (SCCS/1586/17)

A legal issue is still under clarification with DG GROW before possible finalisation. The dossier is therefore **on hold**.

• Fragrance Tagetes (SCCS/1551/15):

For clarity, SCCS adopted by written process a corrigendum of the Opinion including an additional sentence in the conclusion: "not to be used in sunscreen products <u>and products marketed for exposure to natural/artificial UV light"</u>. It will be published, replacing the previous version.

- SCCS input in a JRC survey for a proposal to the OECD for the development of an OECD instrument for Defined Approaches (DAs) for Skin Sensitisation that would make DA predictions covered under Mutual Acceptance of Data (MAD).
- The ECHA report on the regulatory applicability of non-animal approaches reviews their current status under the EU chemicals legislation has been published:

It describes the main types of non-animal approaches, adaptation rules, information requirements and needs for relevant (eco)toxicological properties. For each relevant information requirement, the report describes the potential non-animal approaches, the challenges and future perspectives. SCCS commented this report.
- European Union Reference Laboratory for alternatives to animal testing (EURL-ECVAM hosted by JRC): SCCS Vice-Chair, *Vera Rogiers*, participated in the joint PARERE (EURL ECVAM's Network for Preliminary Assessment of Regulatory Relevance) ESTAF (ECVAM Stakeholder Forum) meeting on 28-29 November 2017 and reported to the group.

The report describes all the activities that EURL ECVAM has undertaken since the publication of the <u>previous report</u> (November 2016) to advance the Three Rs (Replacement, Reduction and Refinement of animal procedures) in collaboration with many other committed organisations.
