A new legal instrument to resolve border obstacles has been proposed by the Commission on 29 May 2018 and is currently being considered by Member States and the European Parliament. There is a specific need for growth in border areas, home to 30% of the European population. The socio-economic development of these regions is often hampered because of their peripheral location and differences in legislation compared to their neighbouring countries. Border regions experience hindrance of free movement of labour and services which leads to disadvantages in economic, social and cultural development. Also, the effects on healthcare systems in these regions are significant. The geographical working area for enterprises and their markets (especially SMEs), healthcare providers and institutions, knowledge workers, educational institutions and regional governments is often a lot smaller than in non-border regions and hence, use of healthcare provisions is less efficient. Furthermore, citizens are limited in their choice of and accessibility to healthcare and there is less opportunity for cooperation in the healthcare market.
