- **Benzophenone-3** A revised draft text has been discussed. New contribution tasks have been allocated to members. A revised draft of the preliminary version will be discussed during the next November WG meeting.
- Octocrylene A revised draft text has been discussed. New contribution tasks have been allocated to members. A revised draft of the preliminary version will be discussed during the next November WG meeting.
- **Hair Dye Acid Yellow 3** C054 the opinion is ON HOLD until November 2020 due to request sent to the Applicant.
