7. INFORMATION FROM CHAIRMAN/MEMBERS/COMMISSION

- The German Cosmetic, Toiletry, Perfumery and Detergent Association (IKW) and German Society for Scientific and Applied Cosmetics) (DGK) organised a seminar on 30 January 2017: SCCS member, *Ulrike Bernauer*, presented the SCCS Notes of Guidance for the testing of the cosmetic ingredients and their safety evaluation (9th revision).
- SCCS Member, *Ulrike Bernauer*, participated in the plenary meeting of the Scientific Committee on Occupational Exposure Limit Values (SCOEL) in Berlin on 8-10 February and reported.
- An IDEA (International Dialogue for the Evaluation of Allergens) workshop meeting on the feasibility of a study to assess the effectiveness of the Quantitative Risk

Assessment (QRA) method is planned on 15/02: Vice-Chair, *Pieter-Jan Coenraads*, is planning to participate as SCCS observer.

- The draft EURL ECVAM Recommendation on the use of non-animal approaches for skin sensitisation assessment was shared by the Joint Research Centre (JRC).
- The Genotoxicity Task Force of Cosmetics Europe invited the SCCS to an all-day international workshop planned on April 26 or April 27 in Brussels, Belgium. SCCS Member, *Maria Dusinska*, is planning to participate.
- An Expert workshop on development and validation of endocrine disrupting chemicals testing is planned by the DG ENV of the European Commission in Brussels on 30 May to 1 June 2017. SCCS member, *Corrado Galli*, is planning to participate.
