# Scientific Committee on Consumer Safety (SCCS) Meeting of the Working Group on Cosmetic Ingredients in Cosmetic Products

13 May 2020, Luxembourg

## **Minutes**

### 1. Welcome and apologies, approval of the agenda and declaration of interests

The Chair welcomed the participants. The meeting was organised via AUDIO due to the COVID crisis. An external SCCS expert from another WG, who is contributing to different files, also joined the audio.

No apology was received.

The agenda was adopted without changes.

The Chair invited participants to declare any interest regarding matters on the agenda. None of the participants declared any interest conflicting with the matters on the agenda.

#### 2. List of points discussed

#### 2.1 New mandates

There was no new official submission of mandate: https://ec.europa.eu/health/scientific\_committees/consumer\_safety/requests\_en

DG GROW informed about a coming mandate on fragrance acetylated vetiver oil - AVO (submission IV) regarding inhalation only (sprayable products). The SCCS identified a lack of inhalation toxicology data for appropriate risk assessment and mandating DG GROW will go back to the Applicant first.

#### 2.2 Draft Opinion discussed

•  $TiO_2$  non-nano for an exemption under Art. 15(1). A revised text has been discussed and new contribution tasks have been allocated to members. A clarification request was sent to the Applicant following the April WG meeting. It

was discussed whether a TiO2 composite material belongs to the actual dossier. Further enquiries will take place.

- **BPA in clothing** A revised draft text has been discussed in particular with respect to realistic exposure and new contribution tasks have been allocated to members.
- **Benzophenone-3** A revised draft text has been discussed and new contribution tasks have been allocated to members.
- **Homosalate** A revised draft text has been discussed and new contribution tasks have been allocated to members.
- **Resorcinol** A reply has been received to the clarification request letter that was sent to the Applicant following the April WG meeting.
- **Propylparaben** New contribution tasks have been allocated to members.
- **Octocrylene** A revised draft text has been discussed and new contribution tasks have been allocated to members. Requested references following the April WG meeting have been received from the Applicant.
- Hair Dye Acid Yellow 3 C054 A draft text has been discussed and contribution tasks have been allocated to members.
