**Reflection process** 

Sub-group 5, on measuring and monitoring the effectiveness of health investments

Lead by Sweden, 12 Member States and Commission



In February 2014, the Council Work Party on Public Health at Senior Level invited Member States and the Commission to set up an Expert Group on Health Systems Performance Assessment (HSPA),

with the following **goals** 

- 1. Set up a forum for exchange of national experience
- 2. Identify tools and methodologies to support national policy makers
- 3. Define criteria and procedures for selecting priority areas
- 4. Intensify EU cooperation with international organisations



#### Work plan 2015 -Goals

- ① To set up a **forum for systematic and thorough exchange of experience** on the use of HSPA at national level. The forum will document its activities, likely on a <u>dedicated web-based platform</u>, to be set up and populated in the course of 2015.
- ② To **select an area in which to develop methodologies and tools** for health systems performance assessment; the findings of this work will be presented in a <u>report</u> that will be likely drafted by the end of December 2015. Behind identifying methodologies and tools, the report will as well present and validate policy actions in relation to the selected priority area.






#### The Chair has invited members to set up two sub groups:

- Quality of care: This sub-group will contribute to draft a report on tools and methodologies to assess quality of care. The first draft of the report will be ready by the end of 2015.
  - First meeting 27<sup>th</sup> of March
- 2. Integrated care: This sub-group will contribute to design a framework for performance assessment of integrated care. It will pave the way for the identification of tools and methodologies, which will be at the core of the work-plan 2016.




Policy actions in relation to HSPA: the policy
