CraNE - Preparing National Comprehensive Cancer Centres and EU Networking

CraNE Joint Action will help deliver higher quality care and reduce inequalities across the EU, while enabling patients to benefit from diagnosis and treatment close to their home.

The CraNE Joint Action aims to improve cancer care in Europe by establishing an EU Network of National Comprehensive Cancer Centres (CCCs). The project aims to make quality-assured early detection, diagnosis, and treatment more accessible to cancer patients. Its main objectives are to establish a sustainable structure for the EU Network, develop a consensus model for CCCs, and improve access to high-quality cancer care. The project also aims to analyse current models of organisation and endorse its sustainability for future implementation.

The CraNE initiative will:



- develop a sound model of the EU Network of Comprehensive Cancer Centres (CCCs) and prepare its design and functionalities;
- define eligibility criteria and governance systems for the EU Network;
- increase the quality of cancer care and promote collaboration between CCCs, with a focus on research and training opportunities;
- establish closer collaboration among CCCs in the EU in the short-term;
- develop different types of networking, cross-border collaborations, and best practice implementation projects in the medium-term;



establish a complete platform for the implementation of the EU Network of CCCs by 2025 with quality standards, education and research frameworks, and quality improvement procedures in place.

Short-term expected results include closer CCC collaboration and improvements in cancer care and research. The medium-term objective is to establish crossborder collaboration and best practice implementation projects. By 2025, the project aims to establish an EU level network of CCCs with quality standards, education and research frameworks, and quality improvement procedures.
