- **PROPYLAMINO BIGUANIDE (PHMB): SUBMISSION III**
The draft Opinion was finalised and will be circulating by written procedure for adoption.
- **ZINC SALTS IN ORAL HYGIENE: SUBMISSION II**
The draft Opinion was discussed. It is planned to be added on the agenda of the next meeting on 19 January 2017.
- **UV-FILTER S87:**
The draft Opinion was discussed. A request to the Applicant was sent out. It is planned to be added on the agenda of the next meeting on 19 January 2017.
- **FRAGRANCE ACETYLATED VETIVER OIL – SUBMISSION III**
The Applicant informed that additional data will be submitted very soon. It is planned to be added on the agenda of the next meeting on 19 January.
