- Weight of Evidence - Memorandum 2024 - update on the finalised chapters.
- Opinion on brain stimulators - external expertise is needed, and a specific call might be launched; literature search will be performed by the Commission Library.
- FORENV cycle VI - mandating Commission Directorate General on Environment to send list of issues to be assessed within this cycle.
