#### 1. OBJECTIVE

Due to widespread interest from industry following the first targeted consultation, and because of substantial modifications introduced in several sections, the IWG and EC have agreed to engage with stakeholders a second targeted consultation on the updated draft guidance (version 12) focused on the sections and/or paragraphs which were significantly modified or which raised most concerns by stakeholders.
