Exchange of health data across Member States



How to exchange health data?

- Cross-border network connecting healthcare providers
- Called eHealth Digital Service Infrastructure (eH DSI)
- To begin exchange of:
 - Patient Summaries
 - ePrescriptions
- Other use cases might follow







Role of Commission

- Support Member States with funding (CEF)
- Provide administrative support and expertise
- Help with the configuration of eHealth NCP
- Provide horizontal building blocks (eg. eID)
- Provide terminology services
- Open NCP Community (chat function)



What is it based on?

- Directive on patients' rights, Article 14
- Work of eHealth Network
- Technical input by large scale research projects (epsos, EXPAND and eSENS) and Joint Actions on eHealth
- eHealth Network takes key decisions regarding the setting up and going life of the eHealth DSI
- Funded from Connecting Europe Facilities (CEF)



Process

- Implementation process has started
- 16 Member States are in the first round
- First Member States start exchange in 2nd half of 2017
- Others to follow gradually
- Process thought to be finished in 4 years
- After 2020, the eHealth DSI should become sustainable



Benefits for patients and health providers

- Seamless cross-border care, improved continuity
- Secure cross-border access to patient information
- Reduction of avoidable medical errors in prescriptions
- Provision of life-saving information im emergency situations
- Reduction of repetition of diagnostic procedures



What does it mean for NCP?

- Health data can follow the patients
- Important to know, for both patient and health provider
- Across which Member States?
- Portability of e-prescriptions and/or patient summaries?
- Which healthcare providers are connected
- ???



Access of citizens to their health data

- Right to access or obtain copy of patient record enshrined in Directive on patients' rights
- Digital solutions empower patient to exercise this right
- eHealth Network to adopt a report and recommendation:
 - Patient access to Electronic Health Records (EHRs)
 - Cross-border portability of EHRs
 - Digital Literacy (ability to access available data)



Link to Digital Single Market Strategy?

- Digital Single Market is one of the priorities of the Commission
- Digital Single Market Strategy adopted in May 2015
- eHealth DSI and initiative on patients' access part of it
- As other initiatives that provide opportunities to patients...
