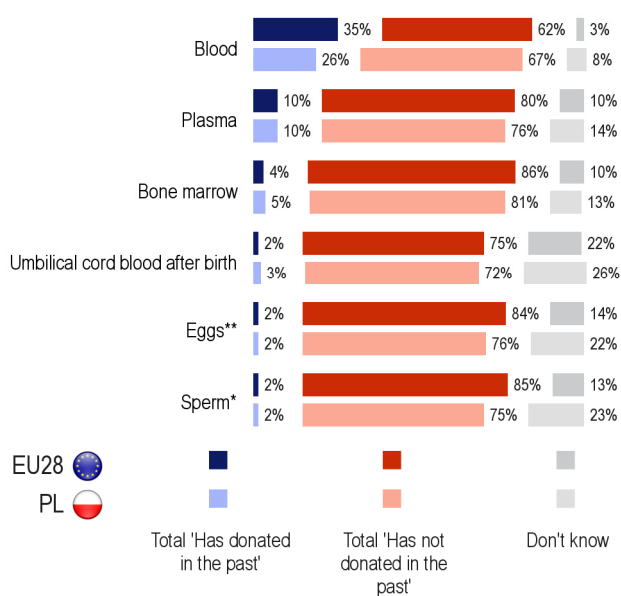

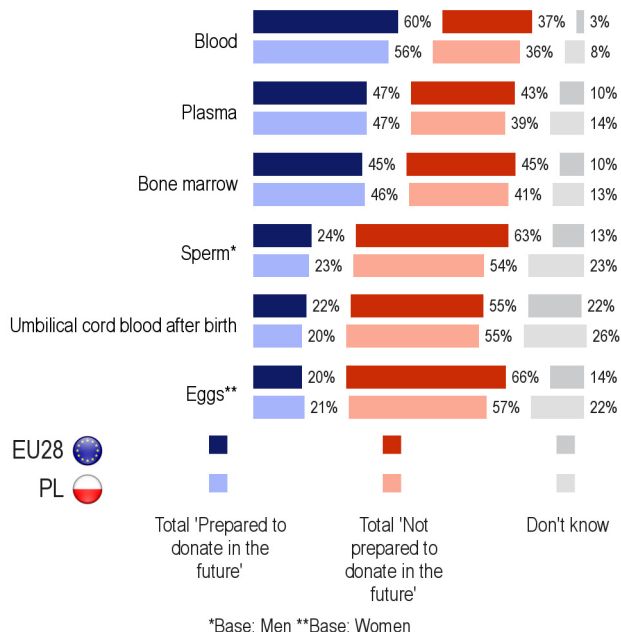

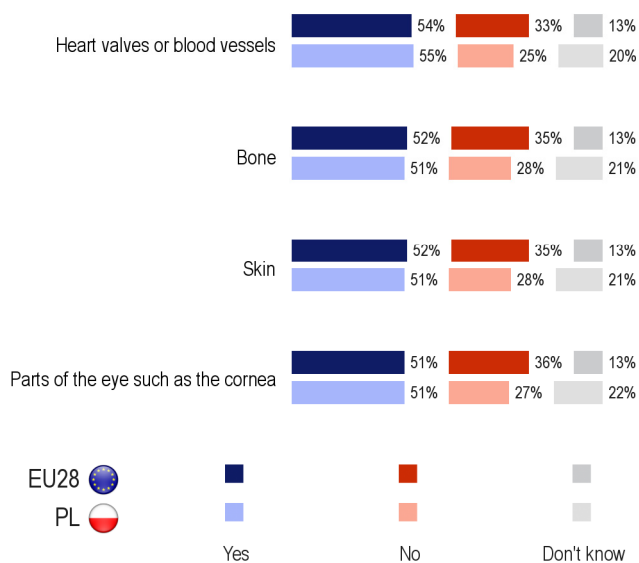

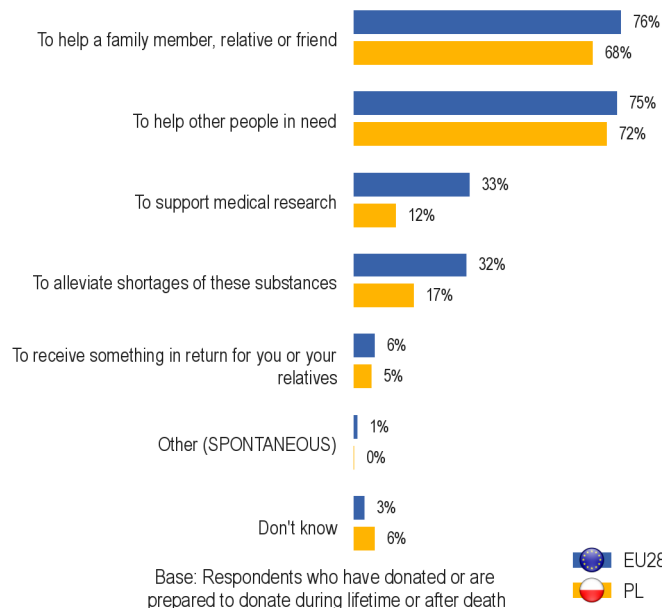

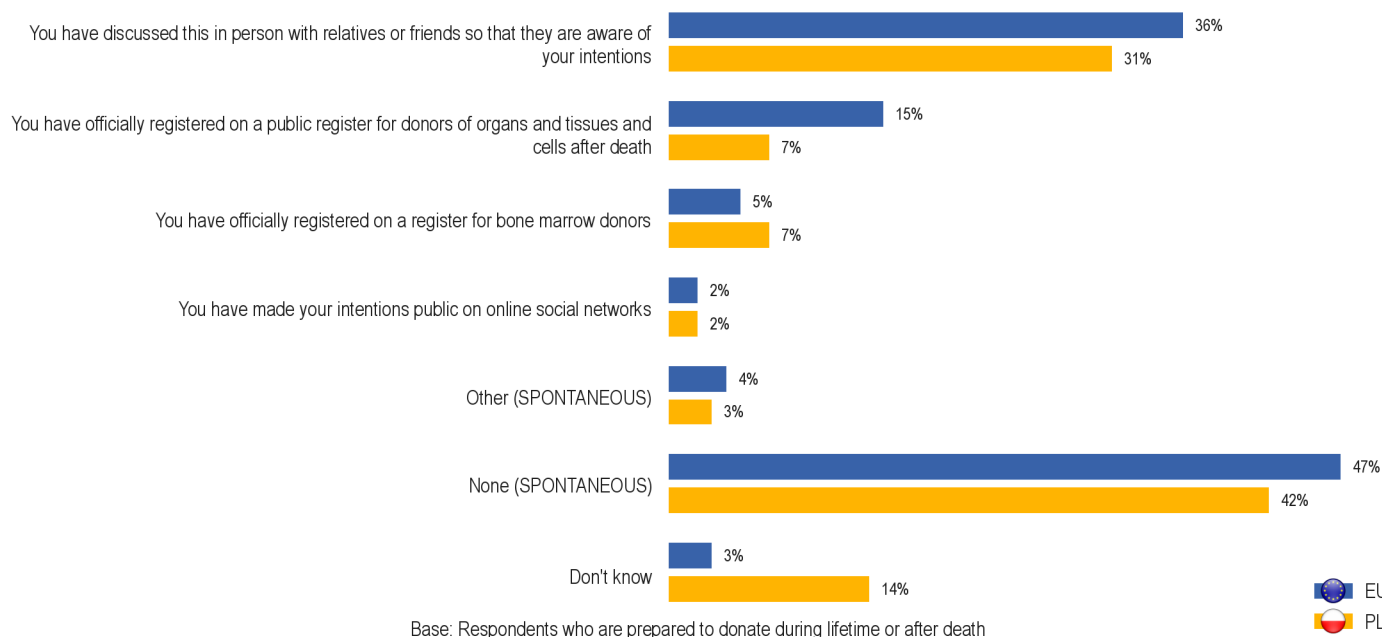

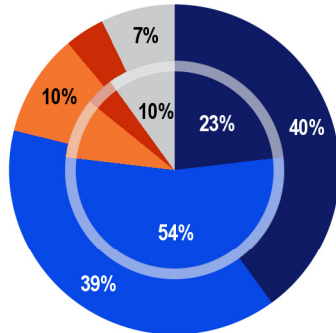

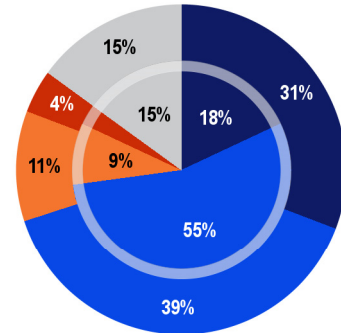

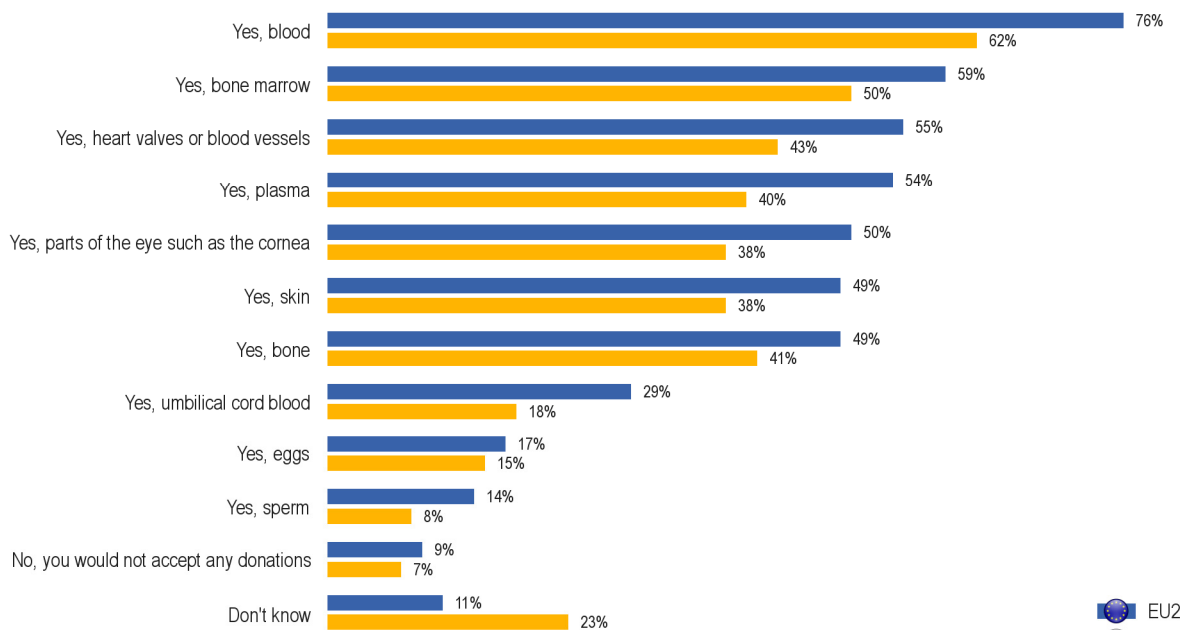

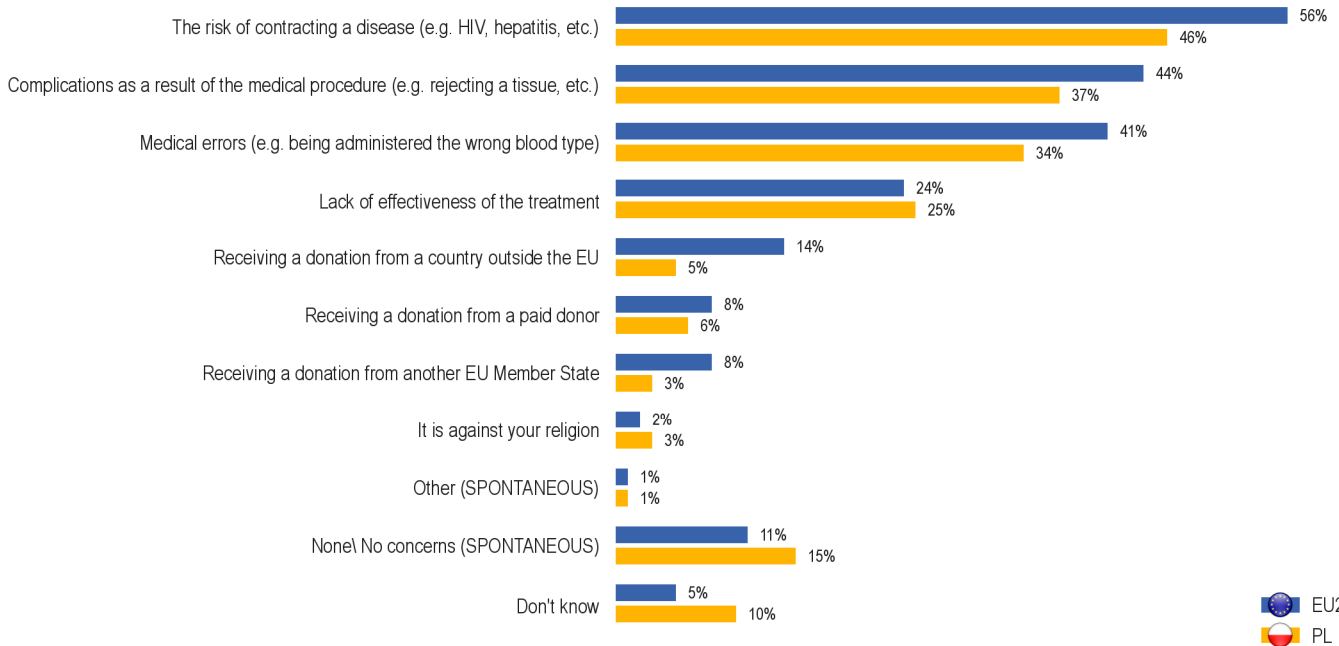

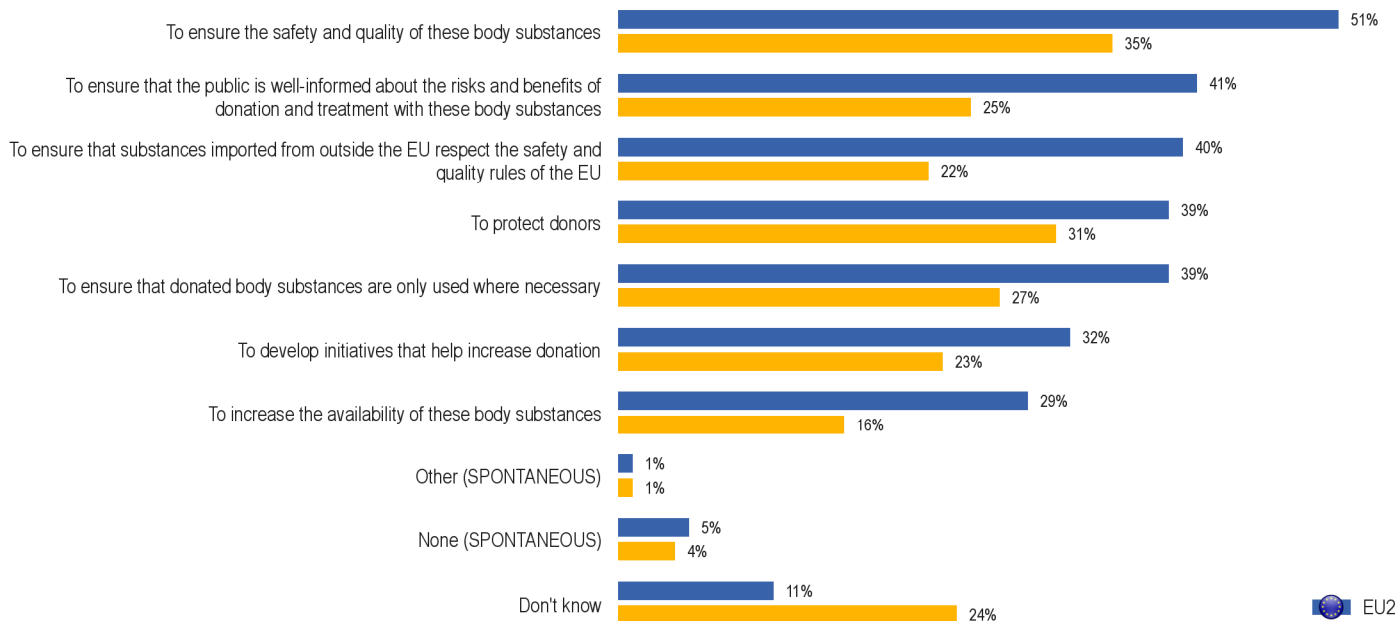
QE8. Which of the following concerns would you have if you were treated with donated blood, cells or tissues? (MULTIPLE ANSWERS POSSIBLE)
