TARGETED CONSULTATION ON

EUDRALEX, VOLUME 4, ANNEX 21: IMPORTATION OF MEDICINAL PRODUCTS

1. OBJECTIVE

In addition to the guidance given in the main chapters and annexes of the EU GMP it was found necessary to publish a specific guideline on importation of medicinal products under a dedicated Annex of the GMP guideline. This Annex 21 precises the principles and guidelines of good practice requirements applicable to a manufacturing import authorisation (MIA) holder which imports medicinal products (human and veterinary) through the EU/EEA borders.

The European Commission therefore expect to receive from the stakeholders concerned by importation of medicinal products, contribution on the guideline revised and potentially to publish the received contributions on the Internet, under the responsibility of the Head of Unit "B4 - Medical products - Quality, Safety, Innovation", Directorate-General for Health and Food Safety, European Commission.
