2.1 New mandates

• Submission I on the use of Dihydroxyacetone (DHA) as hair colorant.

2.2 Draft Opinions (for discussion):

• Hair dye Tetrabromophenol Blue, 4,4'-(4,5,6,7-tetrabromo-1,1-dioxido-3H-2,1-benzoxathiol-3-yliden)bis-2,6-dibromophenol (CAS 4430-25-5)- Colipa No. C183 – Submission IV. A request to Applicant was sent following the plenary meeting. The dossier is on hold until the end of May 2019.

- Hair dye Hydroxypropyl p-phenylenediamine and its dihydrochloride salt (A165). Submission I the draft Opinion has been discussed and is planned to be finalised and adopted at the plenary meeting.
- Hair dye Methylimidazoliumpropyl p-phenylenediamine HCl (A166) (CAS 220158-86-1). Submission I the draft Opinion has been discussed and is planned to be finalised and adopted at the plenary meeting.
- Hair dye Indigofera tinctoria (C170) (CAS 84775-63-3). Submission III The
 applicant replied to the SCCS request and a revised draft Opinion will be
 discussed at the next plenary meeting.
- Aluminium the requested study was received from the Applicant and a new clarification request has been prepared. The Opinion will be further discussed at plenary meeting.
- Zinc pyrithione (P81) (CAS No 13463-41-7, EC No 236-671-3) the dossier has been checked and missing documents have been requested. The SCCS will discuss the file during the plenary meeting.

- Hair dye 1,2,4-trihydroxybenzene (1,2,4-THB) (A33) (CAS 533-73-3). SCCS/1598/18 Submission VI the draft Opinion has been discussed and is planned to be finalised and adopted at the plenary meeting.
- Methoxypropylamino Cyclohexenylidene Ethoxyethylcyanoacetate (S87) -Submission II – the dossier is on hold until November 2019 upon request from the Applicant and agreement from DG GROW.
