On Monday 18 November 2024, the European Commission and the OECD will release the new edition of the flagship publication "Health at a Glance: Europe", kicking off the fifth cycle of the "State of Health in the EU". These issues are fundamental to managing the shifting balance between demand and supply capacity in European health systems.
