Minutes

1. Welcome and apologies, approval of the agenda and declaration of interests

The Chair welcomed the participants and announced one apology. The agenda was adopted without changes.

2. List of points to be discussed

2.1 Draft mandate

Two coatings for Titanium Dioxide (nano form) (Methicone CAS/EC 9004-73-3/236-675-5 and Perfluorooctyl Triethoxysilane CAS/EC 51851-37-7/257-473-3) as UV-filter in dermally applied cosmetic products - Submission II - waiting for official mandate from DG GROW

2.2 Legislative points from GROW

MBBT nano (SCCS/1546/15) - DG GROW asked the WG to clarify healthy vs. damaged skin. The SCCS has evaluated a study using artificially damaged skin and a corrigendum has been added in relation to damaged skin that is devoid of top layers. The changes have been adopted by the SCCS by written procedure on 19 January 2018 and published.

2.3 Draft opinions

- Titanium Dioxide (nano form) as UV-Filter in sprays SCCS/1583/17. Final Opinion was adopted by the SCCS by written procedure on 19 January 2018. The final Opinion is published.
- Nano Silver draft Opinion was finalized and adopted by the WG. It will be presented to the SCCS at the next plenary meeting in February for adoption.
- Nano Acrylates draft Opinion was finalized and adopted by the WG. It will be presented to the SCCS at the next plenary meeting in February for adoption.

2.4 Update of the SCCS nano guidance

• The revision of the Guidance on nanomaterials is on-going. Tasks have been distributed.
