## COMMISSION DECISION

of 16.11.2020

### **appointing a member and an alternate member of the Paediatric Committee to represent patients' associations**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 1901/2006 of the European Parliament and of the Council of 12 December 2006 on medicinal products for paediatric use and amending Regulation (EEC) No 1768/92, Directive 2001/20/EC, Directive 2001/83/EC and Regulation (EC) No 726/2004<sup>1</sup>, and in particular Article 4(1) thereof,

Whereas:

- (1) Article 4(1) of Regulation (EC) No 1901/2006 requires that the Commission appoints representatives of health professionals and patient associations to the European Medicines Agency Paediatric Committee.
- (2) In accordance with Article 4(1) of Regulation (EC) No 1901/2006, a public call for expression of interest has been undertaken by the Commission. The European Parliament has been consulted on the result of the evaluation of the applications received in the framework of this call for expression of interest.
- (3) By its decision of 19 August 2020, the Commission appointed members and alternates of the Paediatric Committee to represent health professionals and patient associations for a term of three years starting on 1 August 2020 and set up a reserve list.
- (4) Where a member or alternate representing patients' associations appointed by this decision is no longer capable of contributing efficiently to the work of the Committee, or resigns, the Commission may replace this member from the reserve list, for the remaining duration of the member's mandate.
- (5) Ms Claus Katrin resigned from her office and has to be replaced until the end of her term of office.
- (6) The Selection Panel suggested to appoint Ms Nora Kriauzaite, appointed originally as an alternate, as a full member.
- (7) Mr Odermarsky from the reserve list confirmed his interest and availability to be appointed as alternate.

HAS DECIDED AS FOLLOWS:

#### *Article 1*

Mr Nora Kriauzaite is hereby appointed as a member of the Paediatric Committee for the remaining period of the term finishing on 31 July 2023.
