Cancer is the primary cause of death for Europeans under 65. Every year around 2.7 million people living in the EU are diagnosed with cancer. The lives lost to cancer in the EU are set to increase by more than 24% by 2035. But 40 % of cancers can be prevented. A lot can be done! Europe's **Beating Cancer Plan** was launched in February 2021 and sets out the Commission's renewed commitment to prevent cancer, support equal access and improve the lives of all those who touched by this disease.


